FYI – Chief Moulden passed the invoice from McCarty for breaking down the Community Center project into three phases to the Fiscal Officer. The invoice was just under \$1,900.00. Chief received new drawings and is waiting on the specifications before sending them to the prosecutor for approval before advertisement.

FYI – Chief Moulden met with Mary Sigmon from Duke Energy to look at their Smart Watt Energy program. Mrs. Sigmon is putting together a proposal as to what it would cost to replace all of the light fixtures with LED lights inside and outside the station and what rebate or reduction amount we would get from Duke Energy for station 55. A meeting is scheduled next week to review her proposal.

**021016-12:** Jason Ritter moved to have the Township General Fund pay \$625.00 for Fire Department Expense Gear. Monies would be part of the \$13,600 of the repayment of the Fire Department Advance. A new line item will be established. 2<sup>nd</sup> by Warren Walker

FYI – Captain Williams has started a community service group that would work on helping citizens of Wayne Township that may be in situations that are desperate and through the group they would be able to connect available community resources to these citizens. FYI – The Fire Department Fish Fry's start this Friday and run each Friday night through March 25<sup>th</sup> at the Newtonsville fire station from 5:30 until 8:00 pm.

**021016-13:** Harold Grosnickle moved to have Chief Moulden apply for the Local Government Safety Capital Grant Program administered through the Local Government Innovation Council for the purchase of two Ambulance Cots and one Cardiac Monitor for a total estimated cost of \$95,000.00. If awarded the Township would have to front the money for the purchase and then be reimbursed from the grant funds. 2<sup>nd</sup> by Jason Ritter

FYI – Chief Moulden has reviewed both the Provident and VFIS Accident and Sickness policies as proposed by both companies. Both policies are similar in their coverage and amounts. The VFIS policy provides a higher level of coverage for our members. The board will stay with the VFIS policy for 2016 at a cost of \$3,083.00.

FYI – Our Insurance Carrier did a reappraisal of the new fire station and states that our coverage is undervalued. They want to change the value from \$1,100,229.00 to \$2,659,281.00. Chief Moulden estimates the value should be about \$1.3 to 1.5 million. Harold Grosnickle will work with Jeff Markovic to dispute the reappraisal.

FYI – A Firefighter One class started on February 1, 2016 that is 100% funded through a grant from the State Fire Marshall's Office. The grant provides 50% of the cost up front and 50% upon

completion. 22 students are enrolled at a course fee of \$1,100.00 for a total income from the class of \$24,200.00. The estimated cost of the class is \$9,500.00 for a potential profit of \$12,500.00.

FYI – An EMT class starting on March 7, 2016 currently has ten students registered with a possibility of three additional students.

FYI – The Fire Department started Ice Rescue Training last night. The Fire Department Auxiliary purchased two Ice Rescue Suits and Ropes. Class room portion is complete and water training will be conducted next Tuesday night. 21 Wayne Township personnel and 6 Jackson Township personnel participated. An automatic aid response run card for Wayne and Jackson Township be implemented for any ice rescue emergencies in either Township.

FYI – A new generator was purchased from Home Depot for \$269.00 was being installed in Rescue 55 today.

FYI – 6 members are participating in an EMT advanced class that completes on March 21, 2016. All members have satisfactory grades.

FYI – Deputy Chief Jewett is working half days on limited duty through February 22<sup>nd</sup> and he will work full days on limited duty with an expected return date to full duty of April 8<sup>th</sup> or sooner.
