Village Clerk Report - Heather Sherman

- Three trustee seats, the Village President and Village Clerk positions will be up for election in April.

Treasurer Report - Jessica Bonnell

Police Report - Dave Woolford (absent)

- Monthly activities: 5 speeding citations, 2 uninsured vehicle citations, 1 unlawful use of electronic communication device and 6 verbal warnings for equipment violations.
- Six letters have been sent out to residents with vehicles on their properties. Which is a violation of village ordinance expired tags/no tags or abandoned.
- A second FOIA request was sent to the Secretary of State on the report of the inspection of Ace Auto Salvage. A response was not received on the first one.
- No bids were received after an ad was placed in the Tonica News for sealed bids on the old squad car.
- The Tonica Police Department is now trained on the use of Narcan. It is used to treat subjects believed to have overdosed on opioids.
- Tonica Police Department is the newest member of ILEAS (Illinois Emergency Alarm System). The membership fee has been waived for this year.

Water & Sewer/Streets & Alley Report - Marc Lemrise

- A lot of locates have been done the last few weeks. Kirby Cable Co. is boring cable through town again.
- Hydrant flushing has been going on.

Engineer's Report - Jack Kusek

- Stabilization has been done on 19th Road and Cherry St.
- Two bids for the asphalt portion of the road work was submitted by Advanced Asphalt in the amount of \$38,660 and UC Paving for \$41,852.84.
