Updated copy of the Safe Route to School to be reviewed. Working on draft plans, 31 trees to be removed has been reduced to 15 trees, two of those have already been taken down. April 1st to November 1st trees cannot be removed due to bats. They also have to watch for other critters and try to relocate them.

e-waste is back on: Teets scrap yard, pallet is in the DPW building,

Flag posts are painted and ready to go up.

Tree next door is next to the electric pole, branches are growing into the electric wire and pushing against the house siding. Do we trim the sides or remove the whole tree? Ray and Chris to look into situation. Also a tree behind the house which may be right over the sewer line. It the tree is taken down they can grind out the stump but not pull the stump. CHIPs we are getting the same as regular and \$1,200 for snow repairs.
