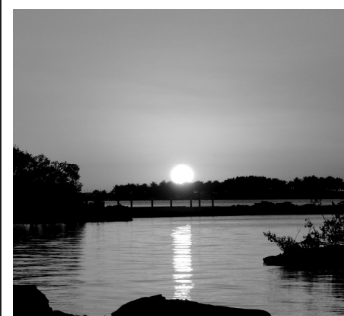
ALL ABOUT US
