# **B.** Special Exception Permit for dog boarding kennel located at N6424 County Road D; Zoning-General Ag—Recommendation to Town Board

Tami Benish was available for information. She is the current owner of the property with Linda Rue as a renter, subject to purchase. The operation is a doggie day-care, a.k.a. Creature Comfort Pet Service. Ms. Benish explained that Ms. Rue was living in Menasha and moved to the country to have farm animals, etc. They have not had any complaints from the neighbors. They do not have any plans for future expansion. The animal waste is put in bio bags into the trash. There is a lower level to the house that opens to the back yard. The dogs can come in to the inside kennels to stay cool in the summer or warm in the winter. There are two wells on the property that have been tested. There could be as many as 20 dogs on the property at any one time. They do not advertise. They have previous clients' animals that are picked up and dropped off. They are not in the dog breeding business. Clerk Gitter will check if they need a multiple dog or kennel license. Chair Coroneos stated that he talked to Constable Janke and there have been no reported complaints.

The Town is under County Zoning and this property is in General Ag. The County's zoning ordinance does not allow for a doggie daycare in General Ag; therefore, a Special Exception Permit is required. Linda Rue/Tami Benish have applied for the permit with the County. The County then requests that the Town Board puts in writing an "approval" or "disapproval" of the permit.

Motion made by Gary Coroneos, seconded by Steve Thompson, to recommend to the Town Board approval of the Special Exception Permit for Linda Rue/Tami Benish. All Ayes. Motion Carried
