

KENOSH SCHOOL BOARD RECALL PETITION INSTRUCTIONS:

DEADLINE – OCTOBER 18, 2021

NOTE: You may NOT collect signatures on school or municipal property. Sidewalks in front of schools and municipal buildings are APPROVED for collecting signatures.

1. **PETITION SIGNERS** must be ELIGIBLE voters who **reside** in the KUSD school district. That includes the City of Kenosha, Village of Pleasant Prairie, Town of Somers, and Village of Somers, WI. ELIGIBLE means 18+ years old, U.S. Citizen, with no criminal record preventing the signer to vote. You do not have to be a REGISTERED voter to sign, only ELIGIBLE. Eligible voters can register to vote any time at myvote.wi.gov
2. **PETITION SIGNERS** – signature, printed name, address, municipality, DATE. Double check for all fields!
3. **CIRCULATOR** (person collecting signatures) - must be a legal resident of the State of Wisconsin, U.S.A. Circulator does NOT have to reside within KUSD. ** Circulator may NOT be a SIGNER on a petition that they circulate. Sign another circulator's form, if you are and eligible signer.
4. **CIRCULATOR** – complete the *Certification of Circulator* with PRINTED name, address, signature and date **ONLY** when the form is ready to submit. Do NOT sign the form until you are finished collecting signatures. Petitions can be submitted with any number of signatures. All 10 fields need not be completed. The signature date on the bottom must NOT precede any of the dated signature dates in the petition.
5. **ORIGINAL HARD COPIES** of each page of each petition MUST be submitted to the petition collectors. Scanned, copied, and photographed images are NOT valid submissions.

The reason must be related to the official responsibilities of the officeholder. **No statement of reason is required to initiate the recall of state, congressional, legislative, judicial, or county officials.**)

INSTRUCTIONS FOR PREPARING RECALL PETITIONS

This is a sample recall petition form. It conforms to the statutory requirements for recall petitions. This form may be reproduced. The Wisconsin Elections Commission has determined that no disclaimer or other attribution statement is required on recall petitions.

Registration - Before circulating a recall petition, the persons or committees seeking to recall an elected official must register with the appropriate filing officer indicating their intent to circulate a recall petition and the name of the officer to be recalled. Petitions for the recall of local election officials must state the reasons for the recall which relate to the official duties of the person to be recalled.

Required Signatures - The number of signatures required to recall an elected official is specified in Wis. Stat. §.9.10(1)(b), (c)s. The filing officer is required to determine and certify to any person the number of signatures required on a recall petition. It is recommended that a person seeking to recall elected officials consult with an attorney concerning the validity of signatures on recall petitions. Wis. Stat. §.9.10(2)(e).

Filing Officer - The recall petition shall be directed to the official with whom nomination papers or a declaration of candidacy for the office of the person to be recalled is filed.

Jurisdiction - The name of the jurisdiction or district that the officeholder represents shall be placed on the recall petition, along with the name of the officeholder to be recalled, and the office held.

Reasons for Recall - Recall petitions for elected officials representing city, village, town, and school district offices must state reasons for the recall which relate to the official duties of the official to be recalled. *No statement of reason is required to initiate the recall of state, congressional, legislative, judicial, or county elected officials. The lines can be left blank.*

Signatures and Printed Names of Electors - Only qualified electors of the jurisdiction or district represented by the officeholder may sign the petition. Each signer must also legibly print their name.

Residential Address of Electors - Each elector's municipality of residence must be listed on the petition, along with the mailing address, including any street, fire or rural route number, box number (if rural route) and street or road name. The Municipality of Residence listed for each signing elector must clearly identify the town, village or city where the elector's voting residence is located. A post office box number alone does not show where the elector actually resides.

Date of Signing - The date the elector signed the petition, including month, day and year, must be indicated. Ditto marks that follow correct and complete address or date information are acceptable. The circulator may add any missing or illegible address or date information before the petition is filed with the filing officer.

Certification of Circulator - The circulator shall personally present the petition to each signer. The circulator may not leave the petition papers unattended on counters or posted on bulletin boards. After obtaining the signatures, the circulator must complete, sign and date the certification on each page of the petition.

Page Numbers - Number each page consecutively, beginning with "1", before submitting to the filing officer. A space for page numbers has been provided in the lower right-hand corner of the form.

Filing Requirements - the petition shall be filed no later than 5:00 p.m. on the 60th day after registration of the recall committee. After the petition is filed, no name may be added or removed. Any signature obtained before registration or after the appropriate circulation period may not be counted. Individuals or committees seeking to recall elected officials should carefully review Wis. Stat. §. 9.10(2)(e), concerning the validity of signatures on recall petitions.

Other Requirements - Individuals or committees petitioning for recall are subject to campaign finance reporting requirements. Wis. Stat. §.11.20(4m). Individuals or committees organized to recall elected officials should carefully review Wis. Stat. §.9.10. If individuals or committees have any questions, they should contact the filing officer of the official to be recalled.
