## VIRGINIA'S STRUGGLE IS OUR STRUGGLE

It is obvious to all that the neo-Marxist enemies of Southern heritage and history are vigorously attacking Virginia. The Old Dominion State of Virginia, the “Mother of Presidents,” and home of some of America’s most notable patriots must not yield to these attacks. The world is watching to see how we respond to these attacks in Virginia. As goes Virginia, so goes the rest of the Confederation. In other words, what happens in Virginia will impact all Southern States. If we lose in Virginia by only offering a weak ineffective fight, that could be the death-knell for Southern heritage. Multiply this situation by all the Southern States and you see why it is a Confederate-wide issue that Virginia, to quote a noted Virginian, “must combine to resist, and that effectually, these encroachments.” If we lose the struggle in Virginia without a manly and aggressive fight, I fear that all is lost.

This is why the Confederate Legion is contacting every SCV camp in Virginia to offer our assistance in promoting a positive view of our Southland to Virginia’s general public. We have already purchased radio ads and are creating a “Virginia” issue of the ‘Southern Defender’ to be distributed across Virginia. We will be establishing a system to assist the local camps to keep pressure on the Virginia Legislature via phone, e-mail, and snail-mail letters to protect Confederate monuments, and holidays, as well as defending our 1<sup>st</sup> and 2<sup>nd</sup> Amendment Rights. Today, we the people of the South find ourselves in the same position as described by that great Virginian, John Randolph of Roanoke: **“We must combine to resist, and that effectually, these encroachments, or the little upon which we now barely subsist will be taken from us.”**

## **GOING ON THE OFFENSE: ATTACK-ATTACK-ATTACK**

As is explained in the January/February issue of the *Confederate Veteran* magazine, 'Forward the Colors,' the SCV is a well-kept secret. At times like this we need to be known as an active and therefore very strong organization defending Southern Rights. Unfortunately, as a group founded in the 19<sup>th</sup> century and maturing as an organization in the 20<sup>th</sup> century, we tend to fight our enemies with 19<sup>th</sup> and 20<sup>th</sup> century weapons and tactics. Unfortunately, our enemies are using 21<sup>st</sup> century weapons and tactics. Think of it like this; If the most powerful WWII (20<sup>th</sup> century) military force was attacked by a very small but well equipped 21<sup>st</sup> century military force the 20<sup>th</sup> century force would be defeated. The same is true for the SCV, if we continue fighting our enemies using outdated weapons and tactics.

The relentless attack by the leftist political/social establishment in Virginia is a perfect example of why the SCV must have a better system of defending and promoting our heritage. Consider these past relentless attacks upon our heritage/history: Charleston, Charlottesville, and Virginia. Notice how fast our enemies can respond to these events and therefore capture the attention of the majority of Americans for their narrative. Now consider how long it took and even now takes the SCV to respond. In WWII as German Blitzkrieg was over-running France, the French military headquarters did not have wireless or telephone connection with its field commanders—headquarters was still using WWI style runners with written messages for communications—the French military did not keep up with technology, the Germans did. This is the state of affairs today as we witness a continuation of the destruction of Southern heritage.

This is not a criticism of previous SCV leaders. They had to work with the tools they had at the time. What the SCV needs to do is to update our ability to respond to our enemies. This cannot be done by volunteers. The Confederate Legion's ability to respond to any attack is hampered by lack of manpower and resources. What is needed is a full-time department at headquarters that will be responsible for reaching out to SCV Divisions, Camps, and members as soon as an "incident" or attack takes place and give those Division, Camps, and members a working plan of action to counter the attack upon our history/heritage. This new full-time department should also daily be working to place SCV information on radio, print media, and social media. At this time, those of us working in the Confederate Legion are attempting to do all of this and more on a volunteer basis. The positive results we are accomplishing with volunteers (4-5 people) can be multiplied a hundred times with a full-time individual. Also, the benefit of a quick and timely response to the news and social media will give us a chance to put our narrative before the public quickly and therefore help stem the tide of anti-South bigotry.

If we do not give new SCV leaders the tools to fight our enemies in a 21<sup>st</sup> century method, the SCV and our Southern Heritage is as doomed as the French military facing the German Blitzkrieg. We can win this fight but we must fight smart—the question is, "Does the SCV have the will to jump into a 21<sup>st</sup> century fight?"

## Legislative Victory in Louisiana

The headline above may be shocking to Louisiana SCV members because in the last two legislative sessions we have been thoroughly defeated by our neo-Marxist opponents. But this has not always been the case! The SCV did win a major legislative victory in our efforts to protect Confederate flags. It occurred back in 1989 when I (Ron Kennedy) was LA Div. Commander. With the help of a friend who was a lobbyist, the LA SCV was able to turn back an effort to remove from state law the legal protection for Confederate flags. The effort taught me an important lesson on how to win in any legislative effort.

I first went to the legislature and met with my representative who immediately dismissed me by curtly informing me that, "I did not come to Baton Rouge to engage in a civil rights fight!" My lobbyist friend told me that I and the SCV were, at best, an unknown entity and at worst "racist." He told me that if we wanted to influence folks in the legislature, we must first demonstrate influence back in their home districts. At the time we only had slightly over 300 members in the Division and around a dozen camps. None-the-less, I contacted activist members in various camps and we began a telephone, fax, and letter writing campaign. For a while the telephone switchboard was very busy handling our calls! We wrote letters-to-the-editor in various newspapers, copied them and mailed them to all legislators. We worked with local groups (VFW etc.) who were sympathetic to protecting historic flags. Through back channels, I made sure certain political "leaders" knew that we planned to use the state's recall mechanism to recall any legislator in conservative districts who voted to remove the Confederate flag from statutory protection. I got word back that the general feeling in the state house was that they did not want to "get those Confederates stirred-up." In the end we won!

The lesson is simple: you do not win a political fight by relying on "truth and justice." In the political world only two things matter—money and votes (this is sad commentary on American politics). We cannot match our enemy's access to money but we can outdo them when it comes to mobilizing voters! Remember, opinion polls document that we have around 70% support among our fellow Southerners. We win by first mobilizing our passive supporters and turning them into active supporters; by flooding our representatives with our demands, and when necessary hiring the right lobbyist. We can win if we use the correct tactics, tactics tied to a strategic plan for ultimate victory!

## Eternal Vigilance is the Price of Liberty Christians, Confederates, Conservatives—Failure
