- Bart began his report with an update on snow removal. Bart met with new drivers to review plowing procedures. A sand stockpile was put in place by Hernandez Landscaping's crew.
- The gates were inspected by Keyhole Security and had the batteries replaced. Bart and Kevin Bennett completed some gate maintenance. The gates will be left open during significant snow events.

- Larry reviewed his monthly report of all activities related to the ADC.
- Larry discussed current construction projects and recently completed homes.
- Edits will be made to the ALDG documents for clarifications on sports courts, hot tubs, lighting, and work hours.
