#### **New Business**

- The status of the Zoning Commission and Zoning Appeals Boards were discussed.
  - Bill Bogantz made a motion to have Dale McCombs continue on the Zoning Appeals Board for 5 year. Dave Cole seconded the motion. The motion passed with all YES votes.
- The contract with Key Properties Realtors is up for renewal for the township owned and rented property at 7111 Northridge Road.
  - Bill Siegel made a motion to extend the rental management agreement with Key Properties Realtors for another year. Bill Bogantz seconded the motion. The motion passed with all YES votes.
- The ODOT Road Salt Contract for 2021 was discussed. The trustees and road supervisor agreed to requesting 185 tons.
  - Bill Siegel made a motion to approve the Resolution Authorizing Participation in the ODOT Road Salt Contracts Awarded in 2021. Bill Bogantz seconded the motion. The motion passed with all YES votes.
- Melodie Bogantz, the Fiscal Officer, mentioned that the township received a new UAN computer and the hardware transfer was completed. Bill Bogantz will use the retired computer for the township security system.
- The Trustees discussed the security system. Bill Bogantz described how our system was useful in catching thieves who stole equipment from a neighbor's barn. The Trustees discussed additional upgrades to our system including getting internet so the system can send alerts in real-time. They also discussed having better lighting in the driveway and purchasing additional cameras. Bill Bogantz will formulate a proposal for the next meeting.
- The Trustees discussed adding a Township Noise Resolution. Rob Clemens of 8790 Crouse
   Wilison described the noise issues at his property. Bill Bogantz is working this issue.
- Bill Siegel discussed the sale price of cemetery plots to Phil White whose land is partially in our township, but whose house is in a neighboring township.
