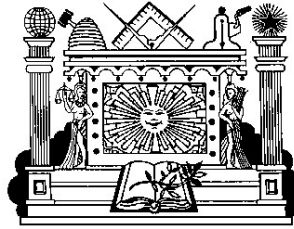

All Worshipful Masters, Matrons, etc. of all Departments, both male and female, shall bring their warrants for inspections by State and National Grand Lodge Officers.

All Grand Masters, National Department Heads, Officers and members of all Sister Grand Lodges and members in good fellowship with their Grand Lodge and the National Grand Lodge are hereby extended an invitation to attend this Grand Lodge Session.
