

Arts-A-Poppin' Show & Sale

EVENT DATE: October 3rd, 2020 - During OCTOBERFEST!

LOCATION: Marshall County Art Guild Gallery, 107 West Commerce St., Lewisburg TN 37091

ELIGIBILITY: This juried competition is open to ALL ARTISTS. Only original artwork conceived by the entrant will be considered. Work copied from any published materials, tracings, famous photos or paintings are not eligible. Please research copyright laws for further information about this law, which protects all artists. All artwork must have been completed within the past FIVE (5) years (Oct. 2015 - 2020). Entries will be viewed by people of all ages. Appropriate subject matter is requested. Any artwork entered may be reviewed by event directors before being accepted for eligibility. Winning entries from previous Arts-A-Poppin' contests are not eligible. However, nonwinning entries from the previous show (2019) may be resubmitted. Our judge will receive a copy of eligibility rules before judging. The judge will review eligibility requirements prior to judging. The gallery will be closed during the judging and the decision of the judge is final. The ARTS-A-POPPIN' Show will post a list of winners outside the gallery after judging.

ENTRY FEES: All Youth entries are free. Residents of Marshall County and Art Guild members have a \$20.00 entry fee. Residents OUTSIDE Marshall County have a \$25.00 entry fee. ALL ENTRANTS are allowed five (5) items per category.

ENTRY PREPARATIONS: All entries must have a completed ENTRY FORM. All paintings should be suitably FRAMED WITH A WIRE FROM SIDE TO SIDE ON THE BACK OF THE FRAME, for ease in hanging by gallery staff. Gallery Staff will be available on entry days to help with determining categories, filling out forms & more.

DEADLINES: Artwork is to be dropped off at the Marshall County Art Guild Gallery on Sept. 16th thru Sept. 30th, 2020, during gallery hours. Each piece of artwork must have a completed entry form attached. ENTRIES WILL NOT BE ACCEPTED AFTER THIS DATE. The Marshall County Art Guild will take every reasonable precaution against loss or damage to entries, but will not be responsible for any such loss or damage.

DAY OF SHOW: Saturday – October 3rd, 2020

Oct. 3 thru Oct. 9, 2020– Visitors Vote on **PEOPLE'S CHOICE**.

Between the Hours of 8:00 am to 2:00 pm – Pictures of winning artwork and artists are taken.

Reception with food for Artists and Public will be Cancel this year due to COVID-19.

The show will stay up until Friday, October 30, 2020. Art work should be picked up during the week of October 26th thru 30th. Any artwork not picked up during this week or other arrangements made with gallery, will become property of Marshall County Art Guild.
