RULES AND REGULATIONS

Heats:

Youth Ages 13-17 as of January 1, 2019

Adults ages 18 & Over as of January 1, 2019

Teams of 3-5 participants** (not required to be in the same age group)

**Individuals may register on no more than two teams (Individual scores will be used in averages for team placings)

- Registration Info: \$20 fee per participant for one course run (\$40 if participating on two teams).
- Scores from one course run will be used for individual and team placings.
- Order of runs will be based on luck of the draw.
- Placings will be based on:
 1. Individual: Fastest course completion time. Team: Highest average of team members points.
 2. Individual: Point values earned for completed obstacles (pre-determined based on obstacle difficulty).
 3. Ties in points for individual placings will be broken by the fastest time (in seconds) to the same point in the course.
 4. Ties in points for team placings will be broken by:
 1. Team with individual member to complete the most obstacles the fastest.
 2. One team member will be nominated to complete one pre-determined obstacle. The individual completing the obstacle the fastest or going the furthest will break the team tie.

GENERAL RULES

- All participants must read and sign the liability waiver.
- No headphones or jewelry while on obstacles.
- No food, drinks, gum or plastic water bottles while on obstacles.
- All clothing and costumes must be family-friendly. At the discretion of the course judges, competitors may be asked to change or cover clothing that is deemed offensive.
- If any part of your body or any of your clothing touches the ground during an obstacle your run will be over.
- Competitors must engage the obstacle only- if you use any portion of the course not intended for competition your run will be over.
- Obstacles must be completed in order.

- Competitors must be barehanded- gloves, chalk, spray, tape and other grip aids are not permitted.
- Shoes are not required but are strongly recommended. To avoid damage to the course, no shoes with teeth or fixed with teeth will be permitted.
- If you leave the course obstacles, platforms or walkways, your run will be over.
- The course cannot be stopped or paused once started for any reason (exceptions sudden severe weather or safety concern identified by course officials).
- Your time will stop when you complete the warped wall or leave an obstacle.
- Only one person on the obstacles at a time.
- Please be respectful of other competitors and set a good example for younger competitors. Competitors engaging in distracting behavior, cat calling or heckling while other competitors are on the course, will be disqualified.
- If you require medical attention at any time while on the course, signal for help and remain where you are until medical assistance arrives.
