and Consent to Photograph, Record, Interview and Publish*

Waiver & Informed Consent to Participate in Volcano Ridge mounted Archers Equestrian Activities, State of Washington Equine Liability Form, and Revised 2007.

Notice: Please read this document before signing. Signing this document affirms you have read its contents and understand it in its entirety.

The Equine Activity Liability laws of the State of Washington, RCW 4.24.540, and states among its statutory provisions that "an equine activity sponsor or an equine professional shall not be liable for an injury to or the death of a participant engaged in equine activity."

Warning of inherent risks:

1) Equine activity is inherently dangerous and equines have: a) the propensity of the animal to behave in ways that may result in injury, harm, or death to persons on or around them, b) the unpredictability of the animals reaction to outside stimulation such as sounds, sudden movement, and unfamiliar objects, persons or other animals; c) collisions with animal or other objects; d) or the potential for a participant to act in a negligent manner that may contribute to injury to the participant or others, such as falling to maintain control over the animal or not acting within his/her ability. An equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities.

2) I acknowledge and agree that the use of archery equipment and any other weapons by myself or others on VRMA premises are inherently dangerous and high-risk activities.

I, the undersigned, having read and understood the content of the document, agree to consent to the provisions contained herein. It is my intention and desire to participate in at Arrowhead Acres LLC in the Volcano Ridge Mounted Archers (VRMA) equestrian related activities, including but not limited to; equine shows, performances, fairs, horse-handling, ground crew support and activities, mounted games and staged combat, equine training and teaching activities, obstacles, equine tricks, trail riding, exhibition, or being present at equestrian activities as an observer or other activity related, however slight, no equestrian activities at events held by the VRMA or Arrowhead Acres LLC.

I hereby acknowledge that I am fully aware of the nature, purpose, and risks of equine activities of the VRMA and Arrowhead Acres LLC. I acknowledge these activities are potentially dangerous and that I voluntarily accept any inherent risks involved. In consideration for my being permitted to take part in these activities, I agree to submit any disagreements or disputes to a board arbitration appointed by the VRMA and abide by any decisions reached by such board. I agree to release and hold harmless, and keep indemnified the VRMA, Arrowhead Acres LLC, its organizers and its agents, officials, servants, representatives, and other practice arenas from and against all claims, actions, costs, expenses, and demands in respect to death, injury, loss or damage to my personal property, howsoever caused, arising out of or in connection with my taking part in these events in the same may have been contributed or occasioned by the negligence of said body or any of its agents, servants or representatives.
