Garbage/Recycling IMPORTANT NOTES

Garbage must be kept separate from recycling and <u>must be out by 7 a.m.</u>

Recyclable items (such as glass, plastic, aluminum) can be co-mingled however, it must be in a tote or clear bag so they can differentiate it from garbage or it will not be picked up. Drivers will start tagging bags and not pick up those that are not compliant. Information sheets can be found on the website or picked up at the office.

Please place garbage and recycling bags/containers on a flat surface and **<u>NOT</u>** in the snow banks.

During extreme weather conditions, pick-up times may be adjusted and items frozen to the ground cannot be picked up.

Licenses not obtained by April 1, 2019 will be subject to a \$5.00 late fee per pet.

Fine for an unlicensed pet is \$218.50

PARKING DURING A SNOW EMERGENCY

A snow emergency will exist when the National Weather Service is predicting a snowfall of 3" or more in any period of 24 hours or less. During a snow emergency no vehicle shall be parked on any street or public way; *EXCEPT* in the downtown business district defined in 8-1-8(g) and any vehicle over 10,000 pounds on the East side of Gillette St. in the 300/400blocks per Village signage.
