TO THE EXTENT NOT PROHIBITED BY LAW, I, FOR MYSELF AND ALL OTHERS CLAIMING BY, THROUGH OR UNDER ME, HEREBY RELEASE, INDEMNIFY AND HOLD HARMLESS THE TOWN OF BEVERLY SHORES AND ITS ELECTED AND APPOINTED OFFICIALS, EMPLOYEES, REPRESENTATIVES AND AGENTS FROM AND AGAINST ANY AND ALL LOSSES, DAMAGES, LIABILITIES, CLAIMS, COSTS AND EXPENSES, INCLUDING BUT NOT LIMITED TO ATTORNEY'S FEES, IN CONNECTION WITH INJURIES TO ANY PERSONS, OR DAMAGE TO OR THEFT OR MISAPPROPRIATION OR LOSS OF THE WATERCRAFT OR OTHER PERSONAL PROPERTY OCCURRING IN OR ABOUT THE BOAT STORAGE AREA OR ANY OTHER PROPERTY UNDER THE JURISDICTION OF THE TOWN OF BEVERLY SHORES OR ARISING FROM THE STORAGE OF MY WATERCRAFT OR OTHER PERSONAL PROPERTY ON THE BOAT STORAGE AREA OR ANY OTHER PROPERTY UNDER THE JURISDICTION OF THE TOWN OF BEVERLY SHORES.

EXHIBIT A

- 1. A watercraft storage permit sticker will be issued by the Town of Beverly Shores Clerk upon completion of this application and payment of the applicable fee. A permit will not be issued for a watercraft that is currently illegally stored on the beach (i.e. outside of the designated boat storage area, or in the designated marram grass). A permit will not be issued to a property owner or resident who is delinquent in their garbage bill payments, or any other payments that are due and owed to the Town. Beverly Shores Town Code § 93.01(B)(3)(e).
- 2. A legally stored watercraft must comply with the following conditions:
 - a. Watercraft must have a valid, current year permit sticker.
 - b. Watercraft must be stored on Beverly Shores property, between the boat storage signs.
 - c. Watercraft cannot be stored on the marram grass, regardless of lake conditions.
- 3. The watercraft storage permit sticker must be securely attached on the starboard bow side of the vessel and maintained on the watercraft at all times when the watercraft is stored on the beach.
- 4. Illegally stored watercraft may be cited with a 15-day warning to comply with storage ordinances. After 15 days, the Town Marshal may confiscate the watercraft and the owner/registrant shall be subject to a fine pursuant to § 93.01 of the Town Code, and the Fee Schedule in § 10.98 of the Town Code.
- 5. All watercraft beach storage, including kayak racks, is on a first-come, first-served basis.
- 6. All watercraft and all personal property must be removed from the beach from November 1 through April 1 of each year. Failure to do so shall subject the watercraft or property to seizure by the Town Marshal. Beverly Shores Town Code § 91.03(B)(4) & (B)(5).
- 7. Seizure, removal, transportation, and storage expenses for illegally stored watercraft shall be borne by the owner and/or registrant. Beverly Shores Town Code § 91.03(B)(5).
- 8. Any personal property, illegally-stored watercraft, or non-registered watercraft that is confiscated or seized by the Town Marshal, and left unclaimed after December 31 of the year in which it is confiscated or seized, shall be subject to sale at public auction, pursuant to § 91.03(B)(5) of the Town Code.
