City of New Munich City Council Minutes

August 7th, 2017

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe, Dan Krueger and Ron Doll were present.

On a motion by Ron Doll, seconded by Shawn Duevel and carried the minutes from July 3rd, 2017 were approved.

The September Council meeting will be Tuesday, September 5th at 6:30pm due to Labor Day.

Fire Chief, Allen Fiedler was present to inform the Council of 4 calls last month. 2 false alarms, one cancelled on route and one fire call with no permit to burn. He submitted a couple of bills that need to be paid, Chief's meeting \$30.00 and Walmart \$58.48.

The East end of 7th Ave is starting to wash out. Pat Nathe will inform the groundskeeper to fill in the area.

On a motion by Pat Nathe, seconded by Dan Krueger, carried and approved the fire department will purchase a flow diverter value to use when flushing hydrants.

Waste /Water Operator, Tom Valerius was present to inform the Council that on well #5 maintenance is complete. The pond area was sprayed. In July we had a booster pump failure. On August 2nd Preferred Controls came out to program and install new pressure transmitter. This came with a 5 year warranty. Frank from Minnesota Rural Water will be coming out on August 15th, to help with the rib at the lagoon. Tom will be doing lead and copper testing in August.

We have about 9 digital meters to install yet. City Clerk, Kelly Thielen will call them to set up an appointment to switch out their meter.

Jaycee member, Sandy Zierden was present to get approval for a one day off-site gamble license for Saturday, August 26th. On a motion by Dan Krueger, seconded by Ron Doll and carried Resolution 8-17-A was approved.

On a motion by Dan Krueger, seconded by Ron Doll and carried the following building permits were approved, Arlene Hendricks and Josh Horstmann.

Brian Thull installed a fence without a building permit. He will take down the fence. Apply for a building permit. Then put the fence back up. On a motion by Dan Krueger,

seconded by Shawn Duevel, carried and approved the penalty of \$100.00 will be waived if he takes down fence and applies for a building permit.

New Munich Hofbrau owner, Amiee Gerads was present for approval to renew her 2am Liquor License. On a motion by Ron Doll, seconded by Shawn Duevel and carried the 2am Liquor License was approved. She also informed the Council that they are going to use their catering license for two outdoor events, one on Saturday August 12th, and Friday August 25th, both noon till midnight. She was informed to have the area fenced off and since she is using her catering license she needs food available. (This does not mean order of the menu).

There is a RV parked on the street on 7th Ave with the slide outs extending onto the street. Mayor, Jim Poepping will give the owner a call to remove it from the street.

Steph Boecker was present to submit a few bills for snow removal and maintenance on 7th Ave.

On a motion by Shawn Duevel, seconded by Roll Doll, carried and approved. Roger Boecker, owner of R-Way Pumping will repair the value and add a shut off value by Main Street near the Post Office and replace the hydrant on Liberty St by 5th Ave. There is a tree that might need to be removed. Mayor Jim will talk to the owner.

On a motion by Shawn Duevel, seconded by Dan Krueger, carried and approved, Worms Lumber will repair Jerry Wiechmann's driveway.

On a motion by Pat Nathe, seconded by Ron Doll and carried the amendment to the Lease and Sub lease agreement with Immaculate Conception Church was approved.

Ray Painter's application to re-zone Antique and Garden Property is tabled till the next scheduled meeting.

Shawn Duevel has some numbers for inspection of rental properties, \$50.00 per inspection/house and \$55.00 per hour for a Sheriff. The Council will review the ordinance. Tabled till next scheduled meeting.

Dean Poepping was present to submit the bill of \$655.00 for the Cord end and pole male end for the generator.

On a motion by Pat Nathe, seconded by Ron Doll, carried and approved. Albany Mutual Telephone will install internet in the City Hall, \$34.00 monthly charge, \$29.95 hook up fee, wireless rotor \$6.95 a month and \$50.00 installation fee.

Dan Krueger informed the Council that he will be resigning from his role as of tonight.

The Council will need to appoint a new Council member. Notices will be posted.
