OFFICE HOURS: The Show Office will be open at 1:30 pm – 7:30 pm Friday, March 13th. During the competition, the office will open approximately one hour before and close approximately one hour following each show day. Faxed entries will be accepted to the Moose Jaw Exhibition Office at 306-692-2762 provided that they are accompanied by payment (Visa, MasterCard, or E-Transfer). MJ Ex Co Office hours are Monday to Friday 9:00 am to 5:00 pm, and the phone number is 306-692-2723.

STABLING: ALL HORSES MUST SHOW OUT OF A STALL. Stabling is assigned and will be available as of 10:00 am Friday, March 13th until 9:00 pm Sunday, March 15th. Stall fees are set at \$60.00 per horse for the weekend – including stall clean out. Shavings may be ordered in advance on the entry forms. There *may* be additional shavings available for purchase during the event. Tack and feed stalls are available for \$30.00 for the weekend and **MUST** be purchased at the time of entry. If you would like to arrive prior to, or stay beyond the times and dates specified, you must contact the Exhibition office in advance to book your stall(s) at an additional \$20.00 per horse per night.

UNLOADING: Trucks and trailers will be allowed 20 (twenty) minutes for unloading at barn doors, and then must be parked in designated areas.

SCHOOLING ROUNDS WILL BE AVAILABLE FROM 1:30 PM TO 7:15 PM FRIDAY, MARCH 13TH. Fifteen minute time blocks may be purchased for \$15 and **MUST** be paid for prior to riding. Time slots can be purchased by a single rider, or by a group/trainer. **SCHOOLING ROUNDS WILL BE LIMITED TO NO MORE THAN 6 HORSES IN THE RING AT ONE TIME.** It is strongly recommended to hack your horse(s) in the Duncan so you do not have to spend much time hacking during your schooling round. Schooling rounds will be scheduled on a first come, first serve basis. The arena will be closed following paid rounds.

INHUMANE TREATMENT OF HORSES WILL NOT BE TOLERATED.

The Moose Jaw Exhibition Company will not be held responsible for any damage, injury, loss, or theft to any person, or their animals, or their belongings.

ALL DOGS MUST BE ON LEASHES AND UNDER CONTROL AT ALL TIMES.

GENERAL RULES & REGULATION

ENTRIES must be in the hands of the show secretary by 5:00 pm Monday, March 9th, 2020. Entries will not be processed without payment. All entries must be made in writing and signed by the owner/agent of the horse and the exhibitor. **The parent or legal guardian MUST sign entries of all JUNIOR riders and the junior's birthdate must be provided.** A separate entry form must be filled out for each horse/rider combination, and will be assigned a separate number.

LATE ENTRIES received after the closing date **WILL** be assessed a \$30 late fee, **NO EXCEPTIONS.** Additional classes may be added to your existing entry form without such late penalties.

RULES: The Committee will be following SHF and WSDAC rules. Participants are requested to read carefully all rules governing this show. Competition rules will follow the Saskatchewan Horse Federation Rule book.

MEMBERSHIPS: All competitors are required to have a current SHF membership, and WSDAC membership if riding in Western Dressage. All memberships must be in place prior to the show. Proof of membership(s) are to be sent in with the entry form.

REFUNDS/CLASS TRANSFERS: Management reserves the right to refund any entry, minus the office fee. Exhibitors are responsible for errors on their entry forms and will not be refunded because of errors. No refunds or transfers on scratches after 5:00 pm Friday, March 13th, 2020.

CANCELLATIONS: There will be no refund on entry fees after the official closing date of entries, except with a veterinary certificate stating that the horse will be unable to show during the show, or a doctor's certificate in the case of the participant. If less than 72 hours' notice is given, with a veterinarian or doctor's certificate, entry fee refunds may be reduced to 50% of the fees at the discretion of show management. **OFFICE FEES ARE NON-REFUNDABLE.** If MJ Ex Co cancels the show due to weather, the office fees will be held and all other fees will be refunded

EXHIBITOR NUMBERS will be assigned per horse/rider combination. Provided numbers **MUST** be worn and visible at all times, including in the schooling rounds, exercise rings, as well as in the show ring. Any exhibitor entering the show ring without the correct exhibitor number may be excused from the class, or may be disqualified in the event of a subsequent protest.

MANAGEMENT reserves the right to cancel or combine any class that does not fill to their satisfaction, whereupon exhibitors shall be notified as soon as possible. The show management is not required to hold the gate for anyone not ready on time, this is a courtesy extended at the discretion of the show committee.

ATTIRE: **ALL** competitors are required to wear an approved ASTM/SEI helmet. Proper attire must be worn as per Association(s) rules.

NOMINATIONS: Heritage Circuit and Prairie Cup approved classes will count towards year end awards. Please ensure your SHF membership is current, and that you have nominated if you are interested in accumulating points for the awards. To qualify for Heritage Provincial Finals September 25-27, 2020, you must attend a minimum of two Heritage Circuit shows and have placed in the top 5 in a division to be eligible.

GOLDEN MILE ARENA RULES APPLY TO OPEN RIDING.

IT IS THE ULTIMATE RESPONSIBILITY OF THE COMPETITOR TO ENSURE THAT HE/SHE IS AWARE OF AND COMPLIES WITH THE RULES.

NO STAPLES, NAILS, SCREWS OR TAPE ON THE STALLS – HOOK OVERS AND TIES ONLY.

ADDITIONAL INFORMATION PERTAINING TO THE SHOW

AGE DIVISION: Exhibitors will be in the following age group using the **age as of January 1st of the current competition year:**

~ Junior Riders – 17 years and under

~ Senior Riders – 18 years and over

JUNIOR'S will be split from each class for placings.

DRESSAGE TESTS will be limited to **approximately 55 tests per day**. You will be placed on a waiting list and contacted if there are any cancellations based on first inquiry.

EC & WSDAC DRESSAGE TESTS will be ridden. Please visit the EC website for English Dressage tests, and Western Dressage of Canada for Western tests, or contact the Moose Jaw Exhibition Company.

A HORSE MAY COMPETE IN ANY TWO (2) CONSECUTIVE LEVELS AND A MAXIMUM OF FOUR (4) TESTS PER DAY

SCORING AND PLACINGS: All scores in dressage will be calculated to the third decimal. When only one horse in a class ribbons will be awarded as follows:

ENGLISH DRESSAGE:

FIRST: 60% or higher; **SECOND:** 57.000% to 59.999%; **THIRD:** 54.000% to 56.999%; **FOURTH:** 51.000% to 53.999%

WESTERN DRESSAGE:

WSDAC rules will apply for scoring and placings at the show, with the exception of results for Heritage Circuit & Prairie Cup placings where SHF rules will apply.

AN AWARD will be given, based on individual tests ridden for the course of the weekend, to the overall highest score and reserve high score of the show.

MARCH TO DRESSAGE SHOW PAID ROUNDS TIME REQUEST FORM

Friday, March 13th, 2020

Rules/Regulations:

1. Fifteen minute time blocks may be purchased for \$15. Payment must be attached with the warm up request form.
2. Time slots can be purchased by a single rider, or by a group of riders. All horse/riders must be registered with the competition to be eligible for a warm-up time.
3. Schooling rounds will be limited to no more than 6 horses in a ring at one time.
4. MJ Ex Co will not be responsible for grouping people together to share the ring.
5. Each horse/rider combination is only allowed to book 1 fifteen minute time slot. A rider can book more than 1 fifteen minute time slot if riding a different horse in each time slot.
6. All warm-up requests will be scheduled on a first come, first serve basis.
7. All riders must be a member of the SHF.
8. Riders will be notified of warm up schedule the Wednesday before competition via email.
9. Professional etiquette must be maintained by all competitors and coaches.
10. No riders will be allowed to ride in the ring during the warm-up time without purchasing a block of time.
11. Other warm up arenas will be available for use.
