

**Index to *The Eighteenth-Century Intelligencer*,
n.s. Volumes 22-25, 2008-2011**

Here follow indices to the new series Volumes 22-25 [2008-2011] of The East-Central American Society for Eighteenth-Century Studies' newsletter (entitled *The East-Central Intelligencer* from spring 1987 to May 2005 and *The Eighteenth-Century Intelligencer* thereafter). The issues were last indexed in the January 2008 newsletter (indexing 2005-2007 issues). Extended pieces are indexed here by contents, with headings by topic, title, and, for books reviewed, author. Entries without author indicated were announcements by the editor. The order within entries is chronological, with year published omitted when the same as the previous entry's. Some duplication and cross referencing occur. An index of contributors is added at the end.
