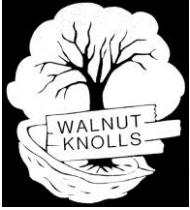
Knolls Residents & Members,

Summer is here and we've put together a plan to access our pool area that coincides with current guidance and use restrictions that were published by Contra Costa County Public Health on Friday, June 5th. Since we are easing into some normalcy here, we appreciate your understanding and patience on how the pool can currently be enjoyed.

Below are the steps we need to follow as a community and how your family can access the facilities:

- **Reservations** - We've created a [Sign-Up Genius here](#) for households to book 1 hour increments at the pool. We offer hourly slots from morning until evening (8:00am-10:00pm). It's on the honor system, so please just book 1 hour only to start. Families may feel this to be limiting, but we want to offer pool use to as many families as possible while social distancing rules apply. We may extend time slots as we gauge use and demand. Daily sign up sheets will be posted down at the pool for reference. **Please remember to remove yourself from the sign-up list if your plans change and you won't use your slot.
- **Group size** - Per county regulations based upon the size of our pools, no more than 6 individuals can be in the large pool and no more than 2 individuals can be in the small pool. For now, we are asking individual households to book slots. The household with the reservation can invite others to join their timeslot as long as the group adheres to the pool limits.
- **Adult supervision** - An adult needs to be present with each reserved swimming group to make sure social distancing rules and use restrictions are followed. County ordinance will be posted down at the pool for reference. We've also configured the current seating and table areas to be six feet apart from each other. - **Cleaning** – Our janitorial service is starting this week. However, we recommend that each family bring their own cleaning materials to clean surface areas that you are using. Tables and chairs should be wiped down with Clorox wipes or equivalent to ensure your safety. Pool railings and doorknobs, fixtures should also be wiped down prior to use. If you feel compelled to clean when you leave, that would be appreciated too. Garbage and recycle bins will be set up for use too.
- **Cleaning Supplies** – We are trying our best to procure and provide Clorox wipes and Purell Hand Sanitizer Dispensers. We are working to source from a local janitorial supply company. We will put the wipes in the bathrooms for use and affix the dispensers around the pool deck area.

Pool will be open to members effective Wednesday, June 10th. If you haven't received a key yet, please contact Kim Carr at (203) 300-4174 (call or text). Old keys can be returned to Kim's house at 1424 Murwood Dr.
