## Neigbourhood Plans:

Further to recent referenda – resolutions were made at the full Council meeting (14 DEC 2023) for the Neigbourhood Development Plans for; Lewknor, Towersey and Wheatley which were seconded by the relevant District Councillors in attendance. Recognising the time and work undertaken to developing these plans, council members were of course delighted to see this positive outcome for all three parishes within our District.

# Joint Motion:

Also at the Council meeting (14 DEC 2023) and with the desperate humanitarian tragedy unfolding in Gaza, council voted unanimously to carry a motion developed jointly by the Lib Dem and Green members to express sympathy and support. It was resolved that the Council • expresses deep sympathy for all those affected by the conflict in Israel and Gaza. To those

in the South Oxfordshire area who have been affected by this conflict we offer our support in this very difficult time;

• hopes for an immediate further release of all hostages and an end to the violence;

• believes Muslims, Jews and people of all faiths and none should feel safe and supported throughout the world and unreservedly condemns the increase in antisemitic and Islam-ophobic violence and abuse in the UK.

The Council resolved to offer appropriate support to any local resident who needs our assistance as a result of these horrific events, to support innocent people displaced and affected by these events, condemns the use of all dehumanising language, and calls on our communities to treat each other with respect and good will and refrain from inflammatory terms to describe either the Palestinian or Israeli populations, especially in a time of crisis.

### Waste Collection Truck:

Several questions were raised, including one to Councillor Rouane (Leader of Council) regarding the purchase of diesel waste collection trucks, bearing in mind the administration's commitment to investing ethically and with the Climate Emergency at the heart of what we do. # Oxfordshire Inclusive Economy Partnership's (OIEP)

The council's commitment to Oxfordshire Inclusive Economy Partnership's (OIEP) charter was confirmed with three initial pledges:

Pledges under the "Support Local and Social" will help to reinforce and focus the council's work to engage local SMEs with procurement opportunities.

This should lead to positive outcomes in helping independent small businesses to thrive.
