2021 Annual Meeting & Elections

In order to keep all our Association members safe and healthy, the Association's 2021 Annual Meeting will be held via video conference. Three Board member terms will be expiring (Wenni Guo, Dean Barnes, and Nelson Ocampo). Voting for the 3 available Board seats will occur ahead of the meeting with the results announced at the meeting. The official meeting notice, ballot, and candidate statements will be mailed out to homeowners in early February. Here are some important upcoming dates:

- Mar-17: Deadline for Ballots can be submitted by mail, email, fax, or drop-off, instructions will be on the ballot.
- Mar-24: Annual Meeting via video conference.

Finance Update

The Board approved the 2021 budget in the August 2020 Board meeting and the annual assessment remains at \$790. The budget can be accessed on the RealManage resident portal. This budget and the 2020 year-end results will be reviewed at the Annual Meeting.

Statements for 2021 dues were issued in early December with a due date of January 1, 2021 and will be considered late by January 30, 2021. Please remit the annual payment of \$790 in a timely manner to avoid collection fees. Additional information about payment options were included on the statement. Architectural Control Committee

Please remember to always obtain ACC approval before making changes to the exterior of your home. The instructions and application can be found on the Community website. For 2020 the ACC processed 45 applications; 24% for roof replacements, 22% for fences, 18% each for driveway modifications, siding replacement or for miscellaneous.

Kirkwood Projects Update

Kirkwood Lift Station Diversion and Abandonment update

The Contractor is continuing the construction progressing down Carriage Hill and across Kirkwood. They will eventually demolish the existing sanitary sewer lift station on the east side of Kirkwood.



Kirkwood Paving and Drainage Project update

The Contractor is continuing into Phase 2 of the project which is the east side of Kirkwood from Lakeside Place Drive south to thru Briar Forest Drive. Construction within the Briar Forest intersection will start in February. Overall completion is the end of 2021. The major work currently consists of demolition of the existing road and the installation of the box culvert. The project number is N-100029-0001-4.
