ATTENTION EXHIBITORS

THIS CLUB DOES NOT AGREE TO ARBITRATE CLAIMS AS SET FORTH ON THE OFFICIAL AKC ENTRY FORM FOR THIS EVENT.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local or state health requirements; for example, proof of rabies vaccination.

1. Fees must accompany entries. This Club and/or Trial Secretary assume no responsibility for incomplete or wrong information on the entry form, or for a dog being entered in a class in which the dog is not eligible to compete, or for entering the same dog twice.
2. The Club will not be responsible for the loss of or damage to any dog entered and exhibited whether the result of accident or other causes. It is distinctly understood that every dog at this show is in the care and control of his handler or his owner at all times.
3. It is the responsibility of the exhibitor to have his dog ready to be shown at the entrance of the judging ring when the steward calls for the class. 4. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or the handler of the dog. There is no rule of this club or of the American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring.
5. Trophies and ribbons will be awarded in the judging rings to the person exhibiting the dog, who will be considered the owner or the agent of the owner. All claims for trophies and other prizes must be made in the judging ring before the completion of the judging of the class, and the Trial Secretary advised at once in the event of any discrepancies. Awards won but not picked up at the show will not be mailed to the winner and the award forfeited.
6. Exhibitors are admonished to make themselves familiar with the rules of the A.K.C. and with the agreement on the reverse side of the entry blanks that accompany this premium list. Rule books may be obtained from the A.K.C., 5580 Centerview Dr., Raleigh, N.C. 27606-3390. When ordering send \$1.00 per copy.
