





*"Son of man, speak to the children of thy people, and say unto them, When I bring the sword upon a land, if the people of the land take a man of their coasts, and set him for their watchman: If when he seeth the sword come upon the land, he blow the trumpet, and warn the people;*

*"Then whosoever heareth the sound of the trumpet, and taketh not warning; if the sword come, and take him away, his blood shall be upon his own head. He heard the sound of the trumpet, and took not warning; his blood shall be upon him. But he that taketh warning shall deliver his soul. But if*

*the watchman see the sword come, and blow not the trumpet, and the people be not warned; if the sword come, and take any person from among them, he is taken away in his iniquity; but his blood will I require at the watchman's hand."* ([Ezekiel 33:2-6](#)).

At the time of this writing, it is almost certain that the Trans World Airways flight 800 was destroyed in flight by a bomb or rocket. The "black boxes" have been recovered. They show evidence of a very brief loud sound and then silence. By the time you receive this newsletter we may know a great deal more about this "mystery."

According to information we have received, The *Sunday Times of London* reported Saturday, July 20, 1996, that Israel had secretly warned U.S. intelligence that an American aircraft could be sabotaged or hijacked by Islamic extremists. This was well before the TWA flight 800 exploded.

"The threat of sabotage or a hijacking against an American plane was analyzed and considered serious enough for us to pass on to the Americans," the source, described as an officer monitoring Middle East terrorist groups, was quoted as saying. This intelligence officer then was quoted as saying, "It was then up to the Americans to assess the dangers and decide whether to pass it on to their airlines." It is important that we include the forgoing intelligence report because of the dialectics involved. The report may be planted disinformation and as we read further in this issue we will see why. It may help us understand who the real culprits are in these acts of terrorism.

Now, also at the time of this writing, a pipe-bomb exploded in the Olympic Park in Atlanta, with two dead and over 100 wounded. An anonymous caller used a public phone in

the park to call 911 to state that a bomb would explode within 30 minutes. Eighteen minutes later the bomb exploded.

According to the *Special Office Brief* (S.O.B., Longborough, Moreton-in-Marsh, GL56 0QG. U.K.) in their July 5th, 1996 Intelligence Report, there will be more acts of international terrorism. They report that the Irish Republican Army is financed by foreign interests who want the British government totally destroyed if Ireland is not released from their control. "Since the beginning of 1996 the IRA has inflicted damage of some 500,000,000 pounds sterling upon the British mainland by conventional terrorism. When it goes nuclear the damage will be lethal. It will go nuclear unless taken out. The paymasters will see to that."

The *Special Office Brief*, which has been in existence since 1935 and has excellent credentials, also states that there is now, or will be shortly, new technology in nuclear warfare which will allow agents with baseball size super bombs to devastate even the Super Powers infrastructure.

The July 5th, 1996 issue of the *Special Office Brief* is exceptionally important relative to these acts of terrorism. They also report that Alexander Lebed, the man who was runner-up to Yeltsin in the recent elections in Russia, is not a Marxist. He does not believe in the U.N. or a New World Order, which means he is a strong Nationalist. He is not pro-Western. He underestimates China and he is a conservative Slavist. You should refer to our [Jan.-Feb. 1996 issue](#) of the Intelligence Newsletter to review the Slavic position in the current Bosnian conflict. Again, we must understand the Balkan situation and its relationship to Islam if we are to comprehend the current outlook for the future of the Western people, including the United States.

It seems that if Alexander Lebed replaces Yeltsin, which appears likely, "he will make a deal with Iran which will guarantee no Islamic intervention within the Russian sphere in return for Russian assistance to Iran, Syria, Libya, Egypt, Sudan and Iraq in their aim to take Jerusalem and exterminate the state of Israel."

What would Israel do, knowing the information in the forgoing paragraph? The *Spotlight* newspaper (300 Independence Ave SE, Washington, D.C. 20003, 800 522-6292) revealed what could be very important in helping us comprehend the complexity of this situation. According to The *Spotlight*, "Senior diplomatic sources in Washington and New York...warn that initial reports attempting to involve Syria in the fatal attack on a U.S. military housing compound at Dhahran, Saudi Arabia are merely the opening notes of the `disinformation campaign Israel habitually launches after such incidents.'" The article then goes on to quote Abdul-Aziz Eshgi, A Saudi foreign correspondent for *Al-Medina*, a leading Saudi newspaper, "I would rank the Israelis at the top among the prime suspects of this terrorist blast." Further, quoting the noted British Broadcast Reporter Terence Gubbins, who has seen more than 20 years of service in the Middle East. "It is the one state where such masked murder and mayhem are the everyday instruments of government policy."

If we combine this report with the other intelligence report involving Israel, we can realize that whoever becomes the indicted "terrorist," we should question the validity of the proceedings. The main point to be realized is that the news media in the United States is completely quiet regarding this information. Why?

The entire world is aflame with acts of terrorism. What is now being witnessed in this country is minute compared to what happens all over the world nearly on a daily basis. England, Ireland, France, the Mideastern countries, India, Russia, etc., observe these acts often. We must understand that all of these incidents are symptoms, not causes.

It is being said that terrorism is an act of cowardice. Perhaps so and there are many throughout the world who consider the bombing of the Kurds by the British in the 1920's and by the Iraqis in the 1990's to be cowardly. There are many throughout the world who believe the fire bombing of Dresden at the end of World War II (which contained only women, children and the sick) to be cowardly. There are many who believe that the forced usage of opium on the Chinese by the British in the 1840's to be cowardly also. There are many who believe that the destructive acts by the eco-terrorists here in the United States are cowardly.

Terrorism, deplorable as it is, becomes an act of war. It is "war on the cheap" because generally there is no official government backing. Again, and most importantly, acts of terrorism are only the symptoms, not the causes.

War has been thrust upon the people of this country by sociological forces from all over the world. Whether we realize that fact or not is immaterial. We must not allow our leaders to react to the symptoms but rather act on the causes. Our leaders, at all levels, have lost their abilities to act instead of react. They have no purpose or goal except for the incessant drive for a one world government, a one world people and a one world religion, the very same goals of Alexander the Great and the Roman Empire.

We have become the Third Rome model. We declare ourselves a nation of law but whose law? It is the law of man and not the law of God. We need to search ourselves and be honest about it. We have failed our God and we have failed our ancestors. How have we failed our God? By throwing away his laws, statutes and judgments. It is so sad that the other peoples of the world know that the laws of God must be followed albeit they consider them the "universal laws." *"If my people, which are called by my name, shall humble themselves, and pray, and seek my face, (follow his laws) and turn from their wicked ways; then will I hear from heaven, and will forgive their sin, and will heal their land."* ([2 Chron 7:14](#)). If we would only read [Deuteronomy, chapter 28](#), and then understand that the precepts given there are universal and we cannot deny them.

There are many peoples of the world who define this country as the "Great Satan." Perhaps foremost among them are the Islamic people. This is solely because of our blind allegiance to Zionism and the country of Israel, which is continuously demonstrated by our government and a large portion of the Christian community. So many of our churches insist that [Deuteronomy, chapter 28](#) does not concern Christians. They insist that it is for the people of Israel. But those people who now live in Israel don't follow the precepts of Deuteronomy, as written. They follow the precepts of the Babylonian Talmud which as Jesus said, speaking to the Talmudic Pharisees, *"Making the word of God of none effect through your tradition, which ye have delivered: and many such like things do ye."*

It is so sad. The other peoples of the world know of these laws. We once did but we gave them up because of the teachings of our "Christian" elders. We have become a Talmudic nation. As Rabbi Bokser stated in his book *The Wisdom of the Talmud* (his title, not mine-ed.), "The judge served in effect as a creator of law and not only as its interpreter-a phenomenon which has been duplicated in every system of jurisprudence." In other words, he says that God did not create the law, statutes and judgments but man did. Isn't that the story of [Genesis three](#)? Man is still trying to be "as gods."

Our leaders gave up [Deuteronomy 28](#) as our churches taught them so now we have been forced into a war against sociological enemies within our borders. We are at war against crime. We are at war against drugs. We are at war against unbiblical immigration. A gender war has been forced upon us. A right to life war has erupted and will not die. The list goes on and on. These can all be classified as manipulated conflicts using the dialectics.

Whenever a war of any sort is declared, it is determined that freedoms and liberties are taken away in order to fight the "enemy." As we look back into history, those freedoms never seem to be returned, even when the "war" has long since disappeared. So it was with the freedoms that Franklin Roosevelt took away during the depression when he modified and reenacted the 1917 War Powers Act. That act on the part of Roosevelt legally declared the United States Citizen as the "enemy." It has yet to be rescinded even though congressmen puff and snort about it in Congress from time to time.

The Gun Control Act of 1934 removed the right for citizens to own automatic weapons. That law was enacted ostensibly to fight the war on whiskey running by the Mafia. When the Prohibition Law was repealed, the Gun Control Act wasn't even considered for repeal. Now, we see that first gun control effort expanded in the ever-increasing effort for total gun confiscation.

We repeat, when we are at war, we lose freedoms and liberty and we never get them back. Americans are awakening to the realization that these "wars" are manufactured for the sole purpose of reducing this country to a third-world status in order to force upon us the age-old dream of a one world government. This same technique is now being played out with the advent of the TWA 800 tragedy. The President has now declared that severe personal and baggage security restrictions will now be employed at our nation's airports. It is estimated that an additional one or two hours time will be required before boarding planes. That is in addition to the loss of personal privacy that all of us have cherished as a right, not a privilege. Already, following the pipe bomb incident at the Olympics, there are certain to be additional reductions in our freedom, liberty and privacy. It all leads to this question. Was the intelligence information received from Israel regarding the Islamic plans of sabotage against our aircraft intentionally ignored? The same question applies to the information received from credible sources regarding the bombing of the military barracks in Dhahran. Those, too, will be resolved in time.

## More On Eco-Terrorism

A very revealing article was found in the *Ecologic* magazine (Nov-Dec 1995) (PO Box 191, Hollow Rock TN, 38342. \$25 per year), which is very relative to the above article because it reflects on one of the sociological wars being conducted against the American people. We print it in its entirety with permission because of its importance. It is entitled "Rewilding America":

"When Dave Foreman first described his vision of a wild America in his book *Confessions of an Eco-Warrior*, only the greenest of the deep ecologist grasped the significance of his dream. Others involved in environmental issues dismissed his dream as the nightmare of a lunatic, who, as co-founder of Earth First! had advocated tree-spiking, and had himself been convicted of conspiracy to blow up power transmission lines. Today, Foreman's dream, known as the Wildlands Project, has been embraced by the United Nations Environment Programme (UNEP) the United Nations Educational, Scientific, and Cultural Organization (UNESCO), the Sierra Club, The Nature Conservancy, the U.S. Department of Interior, and the Environmental Protection Agency. And the project is being implemented relentlessly across America.

"The Wildlands Project is not simply a plan to promote the protection of wildlife or the environment. It is a massive plan aimed at restructuring society around nature as the organizing principle. The concept is Dave Foreman's. The plan, however, was developed by Dr. Reed F. Noss with grants from the Nature Conservancy and the National Audubon Society. It was first published in *Wild Earth*, a publication of the Cenozoic Society, which

Dave Foreman chairs. With a grant from the Ira Hiti Foundation for Deep Ecology, 75,000 copies of the plan were distributed. The Wildlands Project became a corporation with offices in Tucson, Arizona and McMinnville, Oregon. Dave Foreman is Chairman of the Board, and Reed Noss is a Director.

"The Wildlands Project seeks to return 'at least 50 percent' of the land area in America to 'core wilderness areas' where human activity is barred. Core wilderness areas are to be connected by corridors that may be 'several miles wide.' Core areas, including corridors, are to be surrounded by 'buffer zones' in which there may be managed human activity providing that biodiversity protection is the first priority. Noss says that in the core areas as well as in the buffer zones, 'the collective needs of non-human species must take precedence over the needs and desires of humans.'

"Dave Foreman was recently elected to the Board of Directors of the Sierra Club, which has embraced the Wildlands Project as its major endeavor. A special edition of its magazine maps 21 Bioregions in North America and explains the organization's program of implementation. The Fall/Winter 1995 Patagonia catalog features three full pages of the Wildlands Project with a special introduction by Dave Foreman. The promotional piece illustrates the plan's objective with three maps of the state of Florida: as it now is, as it should appear in 10 years, and how it should appear in 100 years. Presently, only about 10 percent of the state is in protected areas. In 10 years, about 40 percent of the state is protected. In 100 years, their map illustrates approximately 90 percent of the land in protected areas and buffer zones. Implementation of the Wildlands Project is underway, not only in Florida, but throughout the nation.

**"The Great Northwest.** The northwestern part of the United States is a high priority bioregion. The Wildlands Project describes an area 'from Yellowstone to the Yukon' that must be protected. The Sierra Club's map identifies the 'Pacific Northwest' bioregion reaching from British Columbia to northern Nevada and eastward to embrace a portion of Montana. The entire area has been teeming with activity for several years, all of which is aimed at driving people off the land in order to create vast stretches of wilderness.

"Attention was first drawn to the area when the Sierra Club Legal Defense Fund, and several other Green Advocacy Groups (GAGs), filed suit to get the spotted owl listed as an endangered species. A series of law suits have resulted in the set-aside of approximately six million acres for the owl. Similar suits filed by both the Sierra Club Legal Defense Fund and the Wilderness Society took aim at salmon and District Court Judge Dan Exra locked up six national forests.

"In 1991, a group of GAGs calling themselves the Greater Yellowstone Coordinating Committee, created a vision document which proposed that 18 million acres around the 2.3 million acre Yellowstone National Park be designated a buffer zone, controlled by the government. Protests by private property owners and in-holders in the proposed buffer zone killed the project. Crown Butte Mines applied for a federal permit to mine an estimated \$600 million in gold from property near the Yellowstone border. The Environmental Impact Statement (EIS) process has taken more than two years and cost nearly \$30 million, and includes detailed plans to clean up the residue of previous mining operations that have occurred over the last 100 years.

"Afraid the Crown Butte's mining plan may be approved, the same GAGs sent a letter to UNESCO's World Heritage Committee and asked them to come evaluate the park for listing as a 'World Heritage Site in Danger.' The park is a World Heritage Site under the World Heritage Treaty signed in the 1970s. The treaty requires that the park be protected beyond its borders.

"George Frampton, former President of the Wilderness Society and now head of the U.S. Fish and Wildlife Service, extended an official invitation to the UNESCO group and agreed to pay their expenses. The site inspection occurred in early September with a decision on listing scheduled for December. The visit by the international body was clearly staged to influence the ultimate decision on Crown Butte's mining application. During the inspection, GAGs asked the World Heritage Committee to recommend an 18 million acre buffer zone around the park.

"Immediately, the Sierra Club Legal Defense Fund launched a new 'Save Yellowstone Now!' campaign. A seven-page solicitation claims Yellowstone will plunge into 'a veritable ecological collapse' unless people send money for their campaign. They promise to save Yellowstone's forests, grizzlies, and water through a 'hard-hitting' campaign of political and legislative action combined with expanded litigation initiatives. To demonstrate the power of their litigation arm, the solicitation included their 1995 docket, which lists 76 lawsuits they are currently pursuing.

"Another organization began working in the area in 1992, the Greater Ecosystem Alliance (GEA). This GAG is significant because its Advisory Board includes both Dave Foreman and Dr. Reed F. Noss. Mitch Friedman is the Executive Director of GEA and is also member of the Board of Directors of the Wildlands Project. The Great Pacific Patagonia is listed among the organizations that provided funding. The group has been working to inventory biological resources, map roadless areas, document watershed and ecosystem boundaries, and in general, developing the data necessary to justify designating the area as a bioregion.

"In 1994, the federal government brought its Ecosystem Management Policy to the area. Two teams, one working in the Upper Columbia River Basin, the other in the Interior Columbia Basin, set out to develop new management plans for the area. Jim Rathbun, a retired U.S. Forest Service Supervisor, has monitored the activity in the area for years. He says of the new developing plan: 'Alternative Theme 7, is essentially the Wildlands Project, and about four out of the remaining six Themes are components of the Wildlands Project.' In a letter to Representative Helen Chenoweth, Rathbun said that public comment had been thwarted because only five working days had been allowed between the mailing of the notice and the deadline for comments. He also said, 'This Administration has found a way to manipulate the process, those that it has allowed to participate in it, and the Congress...to implement ecosystem management in accordance with one or more of their Alternative Themes and not comply with the law.' Manipulation of the law, the courts, and local communities is typical as GAGs continue to implement the Wildlands Project throughout the country.

**"The Great Southwest.** The Gray Ranch is half the size of Rhode Island (502 square miles), located in the boot heel of New Mexico. The U.S. Fish and Wildlife Service wanted to buy the land in the mid 1980s. Local residents were not happy about the prospects of having the U.S. government as a neighbor, so The Nature Conservancy (TNC) bought the property in 1990. A Smithsonian article in February, 1992, described the acquisition as 'the flagship for a whole new program of bio-reserves called Last Great Places.' But four years later, TNC sold the property to Drummond Hadley who said he bought the ranch because 'his neighbors would rather have him own it than any of the others to whom the Conservancy was considering selling.'

"The half-million acre ranch includes the Animas Mountain Range and the Animas Valley, 226,000 acres of private property. The additional 326,000 acres is public land mostly under the authority of the Bureau of Land Management. The ranch is surrounded by another half-million acres of rangeland worked by about 35 ranchers. The entire area is referred to as

the Malpai Borderlands—a million acres of unfragmented lands. Since Hadley bought the ranch, two new not-for-profit organizations have appeared: the Animas Foundation and the Malpai Borderlands Group (MBG).

"The Caird Appraisal Firm was asked to develop a formula for appraising the relative value of public pasture and private pasture lands. His reply was addressed to Malpai Borderlands Group in care of Mike Dennis, Nature Conservancy, Arlington, VA. Mike Dennis is the Legal Council for both the Malpai Borderlands Group and The Nature Conservancy. At least five officials of MBG and the Animas Foundation are, or were recent employees of The Nature Conservancy.

"Local ranchers suspect that the Malpai Grassland Bank program is a subterfuge to expand The Nature Conservancy's control of the Gray ranch or the entire million acres of unfragmented land which the Department of Interior has already proposed to be called the Animas National Wildlife Refuge.

"The Nature Conservancy is less sinister in southern California. In 1993 TNC published a 200 page Strategic Plan: Santa Margarita/Santa Ana Bioreserve. The plan embraces an area that reaches from north of Santa Barbara to the Mexican border and eastward to the San Jacinto Mountains. This five-year, \$30 million project is different from others in that it embraces heavily populated, intensively developed areas. The extremely detailed strategy seeks to 'protect' what is left in this bioregion. 'Our goal is to accomplish most of this protection without acquisition, instead relying on gifts of conservation easements, landowner contact and education programs, homeowner association design review processes, county regulatory controls and incentives including providing flexibility in required building standards, and potential transferable development credit programs. Where conflicts arise that cannot be resolved through these techniques, the Conservancy will purchase crucial parcels and reconfigure them.... Sensitive portions of these properties will be protected by selling the parcel to an appropriate public agency or private conservation buyer with appropriate restrictions.' This plan is complemented by the California Desert Protection Act, sponsored by Senator Diane Feinstein, which creates three new national parks, 74 new wilderness areas and 'protects' 8 million acres outside the area targeted by TNC.

"In Arizona, litigation is the tool to implement the Wildlands Project. The National Audubon Society, Forest Conservation Council, Greater Gila Biodiversity Project, Sierra Club Legal Defense Fund, and other GAGs initiated litigation that closed down 11 national forests resulting in mill closures and other business stoppages that affect thousands of people.

"In Texas, it's the Ecosystem Management Policy. The Fish and Wildlife Service introduced the East Texas Ecosystem Management Plan in September, 1994. The Natural Resources Foundation of Texas obtained a draft copy of the three-year, \$3 million, 73 county plan and immediately scheduled a conference in Lufkin to make state and local officials aware of the proposed plan. Local officials were surprised to learn that east Texas had been targeted for inclusion in the master plan to implement the Wildlands Project.

**"The Great Northeast.** The Adirondack State Park in New York is the heart of the great Northeast Bioregion. The park itself is only three million acres. The state legislature has, however, drawn a 'blue-line' around the park encompassing an additional three million acres of private property that is controlled by the Adirondack Park Commission. Through state-imposed zoning and land use restrictions, private land owners are routinely denied the use of their property with no compensation from the government. The Sierra Club says the Adirondacks is 'a laboratory in which to work out the chemistry...' between people and nature. They admit that the communities within the blue line 'languish- poverty,

unemployment, poor housing, and limited education beg' for solutions. `A constant danger is that people will start to blot out the wilds; the other is that living within ruled-and-regulated nature will prove impossible, and people will be slowly driven into poverty, and wither turn abusive (acts of terrorism?- ed.) or just leave.

"John Davis, editor of *Wild Earth*, and Board member of the Wildlands Project, lives in the Adirondacks. He says: `Human residents need not be asked to relocate, but all people should be required to respect the wildlife of the Adirondacks by refraining from any use of motors, guns, or cows. He says further: `Far from diminishing the economy, declaring the Park a Motor-Free Zone could create thousands of jobs: closing roads, dismantling dams, removing exotic species, packing in food and supplies for the remaining residents, monitoring water quality, reintroducing extirpated species, guiding birdwatchers, and such.' Such is the vision of the Wildlands Project for America.

"The Adirondacks are simply the core area of a much broader bioregion. The Sierra Club identifies a 26 million acre area that reaches through New Hampshire and well into Maine as their `Wild Woods of the East' Bioregion. Still another map adds 50 million more acres that reaches from Maine to Western Pennsylvania. The Northern Forest Alliance is a group of 28 GAGs that have been working in the area for several years. Despite the fact that more than 80 percent of the land in the target area is privately owned, Brock Evans, Vice President of the National Audubon Society told a Tufts University audience: `...I think it all should be in the public domain. We should get it all. Be unreasonable. Yesterday's heresy is today's common wisdom. So I would say, let's take it back, let's take it all back.'

"Congress has never seen a legislative proposal to adopt the Wildlands Project. What Congress sees are incremental steps toward the implementation of the Wildlands Project. The California Desert Protection Act, for example, The Clean Air Act Amendments, and other so-called environmental protection measures all fit into the overall strategy to rewild America. Administrative policies are by far more effective. The vastly expanded definition of `water of the United States' encompasses nearly 200 million acres of private property, which are declared administratively to be wetlands protected under the Clean Water Act. Under the Endangered Species Act, the Department of Interior expanded the meaning of `protected species' to include the habitat that a protected species may use. Such expansion of Administrative power already potentially affects virtually every inch of private property in America. The development of the Ecosystem Management Policy by the Department of Interior and the Environmental Protection Agency brings to bear the weight of the federal government to enforce the initiatives begun in the field by the GAGs.

"Throughout the Administration, key positions are filled by people who formerly were officials in the various GAGs that have promoted the rewilding of America. (This is called Networking.- ed.) The Department of Interior hired Reed Noss, author of the Wildlands Project, to conduct a national study of endangered ecosystems. George Frampton, head of the U.S. Fish and Wildlife Service, who was the President of the Wilderness Society which for years, pushed the Northern Forest Alliance. The infiltration of government by the GAGs doesn't stop in Washington. The former head of the World Resources Institute (WRI) now heads the United Nations Development Program, and WRI's current president, Jonathan Lash, co-chairs the President's Council on Sustainable Development.

"With a relentless army of GAGs working throughout the country, supported, and to a very large extent, funded by the federal government, the rewilding of America is moving forward at breakneck speed. A few members of Congress realize that the Global Environmental Agenda is being implemented in America and are working to stop it. Several members of Congress actually support the implementation of the agenda. But the vast majority of Congressmen are in the dark, influenced only by the current flow of money and

mail. GAGs are steppin up their efforts to influence this Congressional majority. Private property owners and others who prefer to live without excessive regulatory intrusion need to be aware of GAG activity in their own community and alert their elected representatives of the consequences of the Wildlands Project. Without a massive public outcry, the Wildlands Project will continue to crawl across the land devouring individual freedoms, property rights, and prosperity. And Dave Foreman's dream of rewilding America will become a reality." End of article.

You can observe from that article several important points. 1. War has been declared on Americans by a sociological organization. That war is being perpetrated by individuals, some of whom can be classified as eco-terrorists. Notice also that the individual who conceived the idea of Rewilding America was convicted of conspiracy to blow up power transmission lines. This is a major act of terrorism, one which for all other individuals would be declared a felony with a substantial prison sentence.

2. Congress is derelict in its Constitutional duties and allegiance to its constituents. Some members themselves are openly a part of this declared war on America.

3. The Executive Branch is equally, or more so, guilty of conspiring to make war against the citizens. The Forest Service, The Bureau of Land Management, as well as all of the other branches, work for the citizens, not a conspiratorial polycracy of Green Advocacy Groups.

4. This is but another example of the Talmudic concept of government. Returning to Rabbi Bokser's book *The Wisdom of the Talmud*, "The Talmudists declared individual property rights as subject to their consistency with the public welfare. When it is to serve the public interest, these rights may be modified or suspended altogether."

5. In reading the article it becomes obvious that there is an enormous amount of money given to these advocacy groups with which to accomplish their goal of forcing old-time American families to leave their home. It should also be obvious to any Congressman worthy of the name that this country cannot support the livelihood of 250 million people under even a reduced Rewilding America program. One can only conjecture if the old-time American families would have the preference of staying in the event of a mass evacuation!

For us to understand why the people of the United States is being subjected to these humiliations we must understand the political power base of our country. Whatever the political power base is at the federal level, we will see that reflected down to the lowest levels of government. This is so because of the federal mandates to the states and counties in violation of the Tenth Amendment. The political power base must come from some form of "religion." Whenever there is a question put before the Congress, it is connected to a social, moral and religious base. The congressman has only two votes, yes or no and how he answers it is based on his "religion." If his religion is that of man, he votes according to the religion of man. If his religion is Muslim, he votes accordingly. If his religion is Buddhism, he votes in that manner. If his religion is Christian, he votes according to Christ's principles. If his religion is Judeo-Christian, he votes according to the Talmud. If his religion is Judaism, he votes according to the Talmud.

Political Zionism now controls Talmudism, notwithstanding the many Jews who would rather that not be the case. We have become a Talmudic country as Rabbi Bokser points out repeatedly in his book *The Wisdom of the Talmud*. It follows then that Political Zionism has an extremely influential part in the American political system, from the federal level to the county level.

Permitting the Zionists themselves to explain this, we quote an article found in the September 2, 1994 edition of Ma`arw, a Hebrew language daily newspaper published in Tel

Aviv. The article was translated by Dr. Israel Shahak, and is reprinted here in an edited version. It was written by Avinoam Bar-Yosef.

"Several week ago the rabbi of the Adath Yisrael synagogue in Cleveland Park, Washington D.C., dedicated his Sabbath sermon to the Jewish cultural and political center now being formed in America. 'For the first time in American history,' the rabbi said, 'we no longer feel that we live in the diaspora. The U.S. has no longer a government of Goyim (derogatory Hebrew term which refers to Gentiles as cattle), but an administration in which the Jews are full partners in the decision making at all levels. Perhaps the aspects of the Jewish religious law (Talmud) connected with the term 'government of goyim' should be re-examined, since it is an outdated term in the U.S.

"Indeed, as far as the Jews are concerned, President Bill Clinton has contributed toward a real change in administration outlook, having concluded a series of changes which enhance Jewish power, a process that began under President Reagan and his secretary of state, George Shultz. True, the Jewish political influence was also evident in America in previous decades. We have already seen a Jewish secretary of state, Henry Kissinger, enjoying the full confidence of President Richard Nixon. There were Jewish Cabinet members also under Carter. However, they were exceptions proving the rule. Especially, pious Jews were seldom appointed to participate in political work concerning the Middle East.

"The picture now has totally changed, and not only about the Middle East. For example, every morning at about 6 o'clock, several staff cars travel from the CIA center to the White House with senior officers of the American intelligence community, who are about to present to the president and to the four top staffers a PDB, President's Daily Briefing, the term for the most exclusive report in Washington. The document, consisting of 5-7 pages, is often accompanied by top secret satellite photographs transferred by the Pentagon. It is composed in the course of the night by the best American intelligence experts, who analyze the telegrams and reports arriving from the CIA's worldwide network of agents. It contains the most sensitive information regarding developments around the world. Its uniqueness, compared to all other American intelligence documents, lies in the fact that it almost always indicates the source of the information, whether it is a document stolen by a spy, or an agent or 'mole' infiltrating a foreign government, or whether the source is tapped by means of a satellite.

"If Clinton is in Washington, he holds a short discussion on the contents of the document with the five other addressees: Vice President Al Gore, National Security Adviser Anthony Lake, White House Chief of Staff Leon Panetta, Deputy National Security Adviser Samuel Berger, and National Security Adviser to the Vice President Leon Perth. Two of the addressees, Berger and Perth, are warm Jews. They have reached posts that are extremely sensitive for U.S. policy. They are by no means exceptions.

"In the National Security Council, seven out of 11 top staffers are Jews. Clinton has especially placed them in the most sensitive junctions in the U.S. security and foreign policy administrations. Sandy Berger is the deputy chairman of the council; Martin Indyk, the intended ambassador to Israel, is a senior director in charge of the Middle East and South Asia; Dan Schifter, the senior director and adviser to the president, is in charge of Western Europe; Don Steinberg, the senior director and adviser to the president, is in charge of Africa; Richard Feinberg, the senior director and adviser to the president, is in charge of Latin America; Stanley Ross, the senior director and adviser to the president, is in charge of Asia.

"The situation is not much different in the president's office, which is full of warm Jews: the new White House counsel, Abner Mikva; the president's schedule and programs

manager, Ricki Seldman; deputy chief of staff, Phil Leida; economic adviser, Robert Rubin; media director, David Heiser; staff director, Alice Rubin; Ely Segal, in charge of volunteers; Ira Magaziner, in charge of the health program. Two Cabinet members, Labor Secretary Robert Reich and Mickey Kantor, in charge of international trade agreements, are Jewish. They are joined by a long list of senior Jewish officials in the State Department, headed by the chief of the Middle East peace team. Dennis Ross, and followed by many deputy secretaries and even more senior secretaries' chiefs of staff.

"Perhaps the most intriguing thing that happened to me personally in the course of the past year, since I have been posted in Washington, was meeting with organized American Jewry. The best place to see them as they are, the place where I always came each year to admire them, is the annual convention of the pro-Israel lobby, AIPAC.

"I always asked myself what was the value of the Jewish experience in America as far as Israel is concerned. Did the identification with Israel derive from a deep sensation of a common Jewish fate or was it one of the tools of the local community to garner power for achieving truly equal rights in a mixed society comprised also of many immigrants and members of various faiths? Was the Jewish power in the U.S. a phenomenon, which will decrease or increase? Were the intermarriages of Jews with Gentiles threatening to weaken the Jewish power in the U.S.? Or, as I was sometimes afraid, were the American Jews building a new Jewish cultural center that would compete with Israel?

"Adath Ysrael synagogue in Washington is not only a place of worship. It is a Jewish community center, with a prestigious Jewish kindergarten, a Jewish school with Judaism, literature, culture and, of course, Hebrew classes. On Saturdays there are always two separate prayer sessions. The first is the large one, encompassing hundreds of worshippers, which ends in a food blessing at tables tastefully laid with Jewish delicacies. Its members belong to the creme de la creme of Washington society: senior administration officials, successful lawyers, rich businessmen. All are wealthy people. Next week, on the Jewish New Year, the prayers will be joined by many other Jews who usually spend their weekends at the most exclusive clubs, or on the most expensive golf courses, or riding the best horses, or at their expensive houses near the West Virginia lakes, or sailing in their private yachts. Next week, as during all Jewish holiday seasons, the most expensive limousines that can be imagined will stop at the entrance to the synagogue, to let out elegant women, the men mummified in their expensive suits at their side, followed by the well-dressed children. The entrance fee to synagogue is \$1,000 for a single holiday.

"The other synagogue competing for the young generation of wealthy Jews is located in Georgetown. It is a fully Orthodox synagogue, but its prayers are conducted in the Israeli style favored by 'Gush Emunim.' The Israeli flag is proudly displayed above the Sacred Ark alongside the American flag. On each Sabbath the prayers include the benediction for the Israeli Jewish soldiers and the prayer for the welfare of the Israeli government and its officials. Many Jewish administration officials pray there. They not only don't try to conceal their religious affiliation, but go to great lengths to demonstrate their Judaism since it may help their careers greatly.

"The enormous Jewish influence in Washington is not limited to the government. In the Washington media a very significant part of the most important personages and of the presenters of the most popular programs on the TV are warm Jews. A significant portion of senior media correspondents, newspaper editors and analysts are Jewish and many of them are warm Jews too. Many of them are influenced in Israel's favor by attending suitable synagogues. AP's political reporter, Barry Schweid, and The *Washington Post's* education reporter, Amy Schwartz, regularly participate in a prayer session, which is considered to be close to Israel at the Cleveland Park synagogue.

"Let us not forget in this context the Jewish predominance in the Washingtonian academic institutions. At the National Institutes of Health the percentage of Jewish researchers is very much higher than their relative percentage in the population. In the fields of security and science, in the film industry, in art and in literature, the Jewish influence can only be described as immense, with a corresponding enhancement of Jewish power." End of the article.

How has all of this happened to the Christian nations of the West? All of this has now become so commonplace that even to discuss it could possibly be considered "politically incorrect." The changes have been so gradual that what was once called good, now is called evil, etc. ([Isaiah 5:20](#)).

It started before the time of Christ. The lands that Alexander the Great conquered became Hellenized. Not only was Greek spoken, along with Aramaic, but the thought processes and philosophies of the Greeks became the standard. Plato, Socrates and Aristotle were the leaders of this philosophy. However, all that was good in their teaching was modified with the occult and mysticism of the Orient. The resultant philosophy was called neo-Platonism. It likewise was the thought process or exegesis of the Talmud.

One of the philosophies of Plato was the dialectics. With the Talmud as their thesis and the Bible as the antithesis, this neo-platonism was used against the Christians. As a result the Christian movement had heresy after heresy inserted into it.

The early Christian theologians (Origen, Clement, Justin Martyr, Jerome, etc.) thought it expedient to have discourse with the Talmudic Jews, even though the Book of Acts clearly shows that the Apostles and disciples found it to be impossible to communicate with them regarding theology.

The theologies and philosophies of those early church fathers are still used as a standard in modern Christianity. Since this was a Christian nation until a generation or so ago, the politics and government of our country would naturally follow that same line of reasoning. Thus, we get what we deserve.

We must learn to hold our heads high and be proud of who we are. We must not be intimidated by the political and economic power that was arrogantly displayed in the article above. We must begin to really understand what was said in the book of Acts. We must strive for the goal to have it said, "*These that have turned the world upside down are come hither also.*" ([Acts 17:6](#))
