#### 1. Call to Order

Wayne called the meeting to order at 7:03 PM.

## 2. Approval of agenda

Pearl motioned to approve. Douglas seconded. All in favor.

<u>RAC/EAC Resignations and Nomination</u> – Pearl motioned to accept the resignation of Laurie Weekly from the RAC and Vickie Manning from the EAC and to send a letter from the Board to Vickie thanking her for her many years of service. Seconded by Mike. All in favor.

Motion by Pearl to nominate Laurie Weekly to the CA Board for appointment to the Owen Brown EAC. Mike seconded. All in favor.

<u>Bus Stop Proposal at Giant</u> – The Board agreed to table the matter until they had time to hear from the manager of Giant and the property manager of the center. Would also like to hear from Officer Cortez again.

<u>Approve FY19 Board Goals</u> – Motion by Douglas to approve the goals as amended, adding in "Ensure Owen Brown's interest continues to be addressed in the redevelopment of the East Columbia Senior Center." Mike seconded. All in favor.

#### CA Rep (Andy Stack)

- Open Space has finished the updates to the Pavilion and the game tables around Lake Elkhorn.
- The Athletic Club renovations have begun and hope to be completed by November.
- Will be replacing the roof on the Horse Center.
- Roof on the Swim Center is starting to be put back on.
- CA's Trail Stewards program has started: volunteers who walk the pathways with water, maps and first aid kits to provide assistance.

- Received a grant from the State Highway Administration to repair the stream that runs from Wilde Lake to Lake Kittamaqundi.
- County is coming the Kings Contrivance Board to discuss fixes to the Patuxent Trail.
