Regular Meeting ----- April 25, 1991

The meeting was called to order by the Chairman, ATTENDANCE D. L. Taylor at 7:00 A.M. at the District office. Other Board members present were Bobbie Domenick and Gary Wilson.

Special Service District members present were D.L. Taylor, Gary Wilson, George White, Dan Holyoak and William D. McDougald.

Others present were Dale Pierson and Roberta High-land.

After calling for additions or corrections to the MINUTES minutes of the meeting of April 11, 1991, and hearing none, the Chair declared the minutes approved as circulated to the Board.

Dale reported the meeting with the Moab Irrigation MEETING WITH Board was a discussion of the water rights, and they re-MOAB IRRIGA-quested the District to aid them in getting the allotment TION CO. set for 6 AF per acre. He also reported there appears to be no recognition of the culinary water out of the lake. If the culinary use is taken into consideration, we actually have more acreage in the valley than necessary. He will discuss this with Mark Page and make sure Mark takes this into consideration. He also stated his concerns that the increasing of the water per acre could decrease the acreage. These points were discussed. D. L. suggested the District write to the State Engineer, asking for a letter of clarification regarding these rights.

Dale read the letter from the Elks requesting per-FIREWORKS AT mission to have fireworks at Ken's Lake on the 4th of July. KEN'S LAKE Dan moved to approve the request. Bobbie seconded. MOTION CARRIED.

A base radio for the office on Moab City, was dis-BASE RADIO cussed. The options are either a base or another portable. The city will be the final arbiter. The Board agreed by consensus to put in another portable station. Gary will get a cost estimate, and the Board can make a firm decision on the equipment needed.

Pierson has talked to John West about pumping the HECLA SUBD. Hecla Well, and the only way it seems to deal with that WELL well, is to meet with the homeowners in Hecla. Dan's idea was to test pump the well, and if that well delivers what we need, the District could purchase that property and maintain it. Gary suggested the District only maintain the property. D. L. suggested we not do any test pumping until we get an

agreement with the homeowners. It was agreed to set a date HECLA WELL with the homeowners and the District. (Cont.)

Use of springs and other wells in the lower valley PUMPING WELLS to furnish water to Moab Irrigation Co. It was suggested & SPRINGS TO Dale to take Walker to talk to Downad and Clark. It was sug-M.I.C. gsested Dale talk with Delbert Oliver about using Skakel Springs since it is half owned by the City of Moab.

Bobbie Domenick moved to approve the checks. Gary CHECK APPROVAL seconded. MOTION CARRIED.

The meeting adjourned at 8:15 A.M.
