VENUE RENTAL AGREEMENT INFORMATION

TERMS & CONDITIONS OF RENTAL:

- 1. A non refundable deposit of half the rental fee is due at the time of booking.
- 2. The balance will need to be paid no later than 10 business days before the event. If writing a check, you will need to pay the balance 30 days before the event.
- 3. The Renter shall have access to and use of the venue the day of the event for decorating during gallery hours. If additional time is needed, please obtain permission from the owner or staff.
- 4. Decorations are not allowed to be hung or attached to the ceiling, walls, or artwork, unless using blue non-stick residue tape (painter's tape).
- 5. Leftover food can only be left in the refrigerator with consent of the owner or staff of The Historic 1894 and The Gallery. If left, it will be disposed of as the owner/staff sees fit, & additional cleaning fees could apply.
- 6. Renter shall remove all personal property, trash (put in dumpster on Front Street). and all other items that were not present in the venue when Renter took control of it.
- 7. Renter will be liable for any physical damages, legal actions, and/or loss of reputation or business opportunities that Owner may incur as a consequence of the actions of Renter of any of Renter's guests while Renter is in control of the venue, and shall indemnify and hold harmless the Owner against any and all legal actions which may arise from Renter's use of the venue.
- 8. The Gallery can only be rented with approval of The Gallery.
- 9. All events in all event spaces, except 1923 Banana Club, must end before 11p.m.
- 10. Linens are available for additional fees.
