Release and Waiver of Liability and Indemnity

Read Carefully before Signing. This is a Release of Legal Rights.

In consideration of being permitted to participate in any way with In the Spirit Entertainment indicated below and/or being permitted to enter for any purpose any restricted area (herein defined as any area where admittance to the parent(s) and/or legal guardian(s) of the minor participant or none minor participant named below agree:

1. The parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating in activities or events, he or she should inspect the facilities and equipment to be used, and if he or she believes anything is unsafe, the participant should immediately contact Crystal Manning of such condition and refuse to participate. I understand and agree that, if at any time, I feel anything to be unsafe; I will immediately take all precautions to avoid the unsafe area and refuse to participate further.
2. I/We fully understand and acknowledge that:
 - (a) There may be risks and dangers associated with In the Spirit Entertainment activities, which could result in bodily injury which may include a partial and/or total disability, paralysis, and death.
 - (b) The social and economic losses and/or damages, which could result from these risks and dangers described above, could be severe. (c) These risks and dangers may be caused by the action, inaction or negligence of the participant or the action, inaction or negligence of others, including but not limited to, the Releasees named below.
 - (c) There may be other risks not known or are not reasonable foreseeable at this time.

Each of the undersigned further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State in which the event is conducted and that if any portion is held invalid, it is agreed that the balance shall notwithstanding continue in full legal force and effect.

7. On behalf of the participant and individually, the undersigned parent(s) and/or legal guardian(s) for the minor participant, I execute this Waiver and Release. If, despite this release, the participant makes a claim against any of the Releasees, the parent(s) and/or legal guardian(s) will reimburse the Releasee for any money, which they have paid to the participant, or on their behalf, and hold them harmless.

In the event of illness or injury, I do hereby consent to all x-ray examinations, anesthetic, medical, surgical or dental diagnosis or treatment, hospital care and emergency transportation considered necessary in the best judgment of the attending physician, surgeon, or dentist and performed under the supervision of a member of the medical staff of the hospital or facility furnishing medical or dental services.
