Use this chart as your guide for pickup

Items Acceptable for Pickup	Items Unacceptable for Pickup
1. All items bagged, boxed or bundle such as leaves, rubbish, newspapers, etc.	1. Leaves, rubbish, newspapers, etc. NOT boxed, bagged or bundle
2. Tree Limbs-must be less than 6 feet, bundled, and less than 35 pounds	2. Limbs or boards LONGER than 6 feet
3. Trash containers less than 35 gallon size or 75 pounds	3. Tree trucks or concrete heavier than 35 pounds
4. Containerized roofing shingles less than 75 pounds	4. Trash that is mixture of acceptable & unacceptable
5. Minor construction debris that is bundled & less than 75 pounds	5. Containers larger than 35 gallons
	6. Any toxic or hazardous waste
	7. Trash from demolition of a structure

REMINDERS:

- All trash must be placed curbside on Tuesday by 4:00 a.m.
- If your trash/garbage is not in compliance, it will not be picked up. B.F.I will leave a card, and you can call to learn the reason why it was unacceptable for collection.
- Residences are asked to call B.F.I at 363-7995 to have limbs and branches pickup.
- If you are cleaning property or a house please call B.F.I for a dumpster.
- Furniture maybe put out with regular trash.
- To have appliances and (or) branches picked up please call their office and they will put your name on the pick up list.

EVANGELINE PARISH SOLID WASTE COMMISSION

For your convenience, B.F.I. in cooperation with the Evangeline Parish Solid Waste Commission presents the following list of typical items which are acceptable for pickup and a list of typical items which are unacceptable for pickup.

ITEMS UNACCEPTABLE FOR PICKUP

1. Leaves, rubbish, etc. not in containers or bags.
2. Limbs, boards, etc. longer than 6 feet.
3. Limbs, boards, tree trunks, concrete heavier than 35 pounds.
4. Any container heavier than 75 pounds.
5. Any pile of trash originating from demolition of a house or structure.
6. Any pile of trash which is a mixture of acceptable and unacceptable trash.
7. Any container larger than 35 gallons and any toxic or hazardous waste.

ITEMS ACCEPTABLE FOR PICKUP

1. Bagged, boxed or containerized leaves, rubbish, etc.
2. Tree limbs 6 feet or less in length and bundles of 35 pounds or less or call the office to be put on the limb list.
3. Any trash in a trash can not greater than 35 gallons in size or 75 pounds in weight.
4. Minor construction debris bundled in bundles or containers not to exceed 75 pounds each.

POINTS OF INTEREST:

1. All bags and containers must **not** weigh more than 30 pounds.
2. All trash must be set out by 3:00 a.m. on your designated collection day.
3. All trash must be placed curbside - Definition of curbside - Each residential container, bag, bundle, shall be placed as close to the right of way as practical without interfering with or endangering the movement of vehicles or pedestrians. When construction work is being performed in the right of way, containers, bags and bundles shall be placed as close as practical to an access point for the collection vehicle. The Contractor may decline to collect any container, bag or bundle not so placed.
4. Since we are supplying house-to-house garbage collection and 4 parish dumpster sites, there is absolutely no excuse for dumping trash and garbage on our roadsides. If you witness anyone dumping on our roadsides or waterways, please notify your local law enforcement, sheriff's department or the Solid Waste Commission immediately and give them all the details possible. If we all work together, we can make Evangeline Parish a clean place to live and work.
5. If any trash or garbage is not in compliance, B.F.I. will leave you a card stating why. You can call them and they will explain why it was not picked up.
