A NOTE FROM THE GLEN LAUREL BOARD

Hello Glen Laurel Residents!

As we head into spring, there are several projects the HOA Board would like to make you aware of. The first is a walking trail around Lake A, which is located off of Imperial Canyon near the park. The new sidewalks will connect to the existing sidewalk that runs parallel with Imperial Canyon and continue around the entire lake. Once completed, the four foot wide concrete path will be approximately a half mile long. The project, which is being funded by the Burney Road MUD, will take no more than 75 days to complete.

The second project is regarding improvements to our community pool. The pool itself (as well as the kiddie pool) will be drained and re-plastered for the upcoming pool season. The bottom portions of the columns around the exterior of the pool house are being wrapped in stone to match the main building after extensive rot was found on them. Once these repairs are completed, the parking lot will be power washed and re-stripped. We hope these improvements continue to enhance the overall look of our neighborhood and bring value to our homes.

Other projects in consideration for the Board continue to be a plan to raise the height of the south monument on West Airport Drive. This is a project that we feel is likely needed but the Board is re-evaluating bids for this work in lieu of the work being performed at the pool as a higher priority. Therefore, this project is currently postponed to a later date. Additionally, with the new sidewalk going in by BRMUD, the Board may also want to consider adding additional parking in the park area for residential use. A preliminary scope has been identified and an estimate for what this project could cost would still need to be evaluated. This is a longer term project that is still in the early stages of consideration so stay tuned for further updates.

The Architectural Control Committee (ACC) helps ensure that our neighborhood reflects the pride and care of its residents. The purpose of the ACC is to focus on structural, landscape and general upkeep and to ensure compliance to those conditions as outlined in our Covenants, Conditions and Restrictions. All changes and improvements made to the exterior of your home must be approved by the ACC. Please do not start work until you have received an approval notice from the ACC. Failure to do so may result in the work being removed at the homeowner's expense.




