New Ground Penetrating Radar Survey at Fort Daniel

ast month Eric and Jason (pictured below) of genesis Radar Imaging, came to the Fort Daniel site

and did some GPR work on areas that had not been done before as well as some previously surveyed areas.

Eric and Jason were able to confirm that no interruption in the original excavation of the west wall trench can be detected—supporting the conclusion that there was only one gate located in the east wall. It was this interruption that allowed us to pinpoint the exact location of that east wall gate. These early forts could have

had one or two gates, but according to the "Knox Plan" and what we know about other 1814 forts

(such as Fort Madison, Fort Lawrence and Fort I the ground penetrating radar (GPR) firm, Xeno- Mitchell), there were two gates at these forts. Two gates at Fort Daniel would have allowed us more

> easily to conjecture that the Knox Plan (actually a plan suggested by President Washington for militia forts, and submitted to the Governor in 1794 by his Secretary of State, Henry Knox) was followed for interior structures as we see from construction plans submitted for payment of the construction of the two blockhouses by Isham Williams and George Kennerly in 1797.

> Another interesting find was that a particularly large feature

(first recorded by Calvin Skaggs in his 2007 site



survey) had one or more metal objects at a depth of three feet. Skaggs' survey was of soil disturbances only; whereas Eric's was set up to discriminate objects as well and determine if they were iron. These metal objects registered as iron. However, why would there be iron that deep since the only known features that deep are the wall trenches and the cold cellar?

In the survey results map (*pictured right*) we see that this feature (F8) appears to be similar to another one (F7) that we tested in 2011–2012. Feature 7 turned out to be a "stump pull." The only artifacts in that feature were prehistoric, which made sense, since the stump was pulled in preparation for construction of the fort. No historic artifacts were found in the backfill of this cavity because none had yet been dropped. Compare this to the collapsed rodent den that Dr. Jeff Glover and his Georgia State University (GSU) students excavated within the Northeast Blockhouse during 2011–2014. Though it was not three feet deep, it did contain both historic and prehistoric artifacts which had been in the plow zone above it.

However, as can be seen in the survey results map, Feature 8 is outside the palisade wall trench. With iron about three feet from the present surface this feature is deeper than the wall trench and the cold cellar. If Feature 8 is a stump pull, my hypothesis is that the iron was dropped by the men who were pulling the stump and immediately back filling the cavity. Therefore, we should expect to find only prehistoric artifacts in the fill *except*, possibly, in the plow zone that now covers it—containing both prehistoric and historic artifacts. Below the plow zone there would be only prehistoric artifacts, and the iron would be at the very bottom of the stump pull backfill.

New findings will be excavated by visitors to the 11th Annual Frontier

Faire on October 19 (see Page 2 for more details) as well as by GSU archaeology students. GSU students will also be continuing with work at the cold cellar feature in the Southwest Blockhouse. Dr. Glover expects a good turnout of his students, and FDF board member Tyler Holman expects some of his classmates from University of North Georgia to be there as well. Xenogenesis will also be at the Frontier Faire demonstrating the wonders of GPR for archaeology. ■ JJD

Diving with a Purpose

Diving with a Purpose program teaches students to be underwater archaeologists. As part of the this program, a group of African-American teenagers went searching for a sunken slave ship, and it changed how they view

slavery. Above water they confront the history of slavery they find below. However, back onshore, the student divers—tasked with helping the National Park Service survey historic shipwreck—sometimes struggle to talk about their mission. The students, part of the Youth Diving With a Purpose program, are predominantly African American and many descendants of enslaved Americans. Finding passion in an

activity tied to slavery sometimes fills them with another emotion; shame.

Howard University psychologist Gishawn Mance said the sense of shame largely stems from the narrow frame in which slavery is often presented. In classrooms and popular culture it's depicted as an isolated historical event, she said,

devoid of context and disconnected from other African-American experiences. "It is a historical time frame that these people experienced, but it is not the only story. It's part of a rich history," she said. "The lack of context and nuance facilitates a gamut of emotions."

Moving beyond victim-centric narratives and including

stories that counter popular notions of the era helps present a view of African-American history that instills pride instead of shame. Underwater the student divers are searching for the Guerrero slave ship, which crashed in 1827, after the slave trade was outlawed in the United States.

For these students playing a role in building that more nuanced story of

American slavery has created a deeper connection to their ancestors. Youth Diving With a Purpose gives the teens a more experiential understanding of slavery than their high school classrooms can provide as well as an opportunity to contribute to a more accurate documentation of American history.
