Once again, we have a full complement of guests as we host a Gubernatorial Candidate Forum. Six candidates for the Republican nomination have confirmed that they will join us. I'll attempt to keep the candidates' responses direct and on point. In order to maximize your ability to ask questions, the candidates' comments and answers will be subject to a time limit (to which all of them have agreed). This

promises to be another great opportunity for us to learn about and evaluate our candidates for the very important office of Governor.

Looking ahead to our June 12 meeting, we will be hosting an LD23 House Candidate Forum. Please make plans to attend and encourage your fellow PC's to come along for these important and informative evenings.

### **Minutes**

With concurrence of the members present, the District Meeting of the members of Arizona Republican Legislative District 23, held at Mustang Library, located at 10101 North 90<sup>th</sup> Street, Scottsdale, AZ 85258 on April 10, 2014 was called to order by 1st Vice Chair Nancy Ordowski at 7:02 pm.

The Invocation was given by Dr. C.T. Wright. The Pledge of Allegiance was led by Chris Brant.

# Nancy Ordowski, acting Chair:

# Rich Rutkowski, 2nd Vice Chair:

Rich explained the evenings format change and then proceeded to remind everyone of upcoming meetings and events.

The next meeting of LD23 on May 8th will be at St Barnard's Church on 124th St just north of Shea Blvd, Scottsdale. The information will be in the next newsletter. The annual breakfast will be May 3rd and Shirley will give more information later in the meeting. Petitions for Congressman David Schweikert are in the lobby for those who want to get signatures for David and you can deliver those petitions you already have.

He then introduced the program of speakers by explaining the rules and noted the timer would be managed by the Secretary. When the timer rings and the red flag is raised, that means the time is up. Rich explained he had informed each candidate previously of the rules and the time they would be allowed and all candidates agreed to the rules. Questions will be asked by PCs if time permits.

Rich explained the rules for the speakers, that we have a full agenda and limited time. Rich asked candidate speakers please refrain from criticizing their opponents unless they have documentation to back up their comments.

- 1. Former LD23 Chair, Doug Little, candidate for Arizona Corporation Commission spoke first.
- 2. Attorney General Tom Horne and candidate for re-election led off the Attorney General speakers followed by Attorney General candidate Mark Brnovich. Q&A was taken to fill out Horne's allotted time.
- 3. Candidates for Secretary of State, LD23 Senator Michele Reagan and LD25 Representative Justin Pierce were present for the Secretary of State Forum. Rich explained that Wil Cardon was unavailable to attend due to a prior commitment. The candidates led off with a 2 minute introduction, questions from the assembly for both candidates, and 3 minutes for closing statements.

# **Approval of the Minutes:**

Acting Chair Ordowski called for approval of minutes from the March 2014 District meeting. A motion to accept the minutes was made by Ray Wallage, seconded by John Strasser. There being no discussion, the motion passed.

## **Treasurer's Report:**

Nancy introduced the new Treasurer, Gayla Coletto. Gayla explained the report she was presenting was the final report from former Treasurer Linda Rizzo that was previously posted in the newsletter.

Gayla reported that donations were due and the suggested amount is \$30 for individuals, \$50 for couples of household and \$100 at the Chairman's level. Following the reading of the report, Gayla read the written explanation of the expenses and then read a statement by Linda Rizzo to wide applause.

There being no need for a motion to accept the Treasurer's Report, the report was accepted by General Consent.

### **Chairman's Business:**

Nancy Ordowski reminded the assembly that CD6 Congressman Schweikert needs petition signatures and they can be mailed directly to David as collected.

Jim O'Connoroutlined a program by MCRC Chairman LaFaro for those in the four safe CD's to help CD9 candidates get on the ballot to defeat Kyrsten Sinema, Democrat. Volunteer PCs have time and talent and are asked to channel those resources in to CD9 to carpet bomb Sinema. Republican candidates are Andrew Walter and Wendy Rogers. Jim has sign up sheets for volunteers for every Saturday until the filing deadline. With this help, CD9 is a winnable seat. As a side note, all Republican Congressmen throughout Arizona are on board with this plan as all of them are in safe Districts.

# Shirley Cordasco, Special Events, Annual Breakfast

This meeting will be the last time to see Shirley before the annual breakfast on May 3rd which is in three weeks. With the help of Arthur Cooper, Shirley stated that she needs money for reservations. ## Nancy Ordowski, 1st Vice Chair Report:

An i360 Training Schedule:

It is time for PCs to get their affidavit filled out and notarized, get their petitions with 10 signatures on the front and filled out on the back by the PC. ALL the information at the top of the affidavit needs to be filled out and notarized. The completed petition must be on one page, front and back, turned in to the county along with the affidavit between 4/28/2014 and 5/28/2014. Nancy will be collecting the petitions at the next meeting. All current PCs have to re-apply to be PCs for a new two year term. Their names will be on the ballot if there are more applications than there are seats available in each precinct.

Nancy stated she needs to know the names of PC captains for the 57 precincts. She also has been given no information on Area Directors, either, and needs those Area Directors to contact her as soon as possible.

The i360 training will start in the next few weeks and Nancy will be working with Area Directors and PC Captain's first. Each PC needs tablet's or smart phones to use the program digitally but for those who do not have those devices, they will get printed walk sheets.

The AZGOP wants to have picture name badges for those walking neighborhoods. Please come to the May 8th meeting ready to have your photo taken at no cost to the PCs. The meeting will be at St. Barnard's church.
