

VintageArchery.Org General Terms and Conditions

Payment

All orders must be prepaid. We accept PayPal or Visa, Master Card, Discover and American Express credit cards **via a PayPay Invoice sent to your email** address from which you pay with your credit card. Email orders may also be paid with a cashier's check or a money order. Personal checks and money orders will be accepted but will need to be verified by your bank and clear before shipment.

Returns

We try to describe and picture the equipment accurately. If we have failed to include a material defect in a product that significantly affects its market value, we may provide a partial refund. We accept returns upon the following conditions: 1) The return is subject to a \$25.00 restocking fee; 2) the buyer is responsible for returning the product in the same condition as it was originally shipped (as provided in the sales description brochure). If the bow or other product is damaged by the return shipping, we will deduct the estimated cost of the damage, at our complete and full discretion, from the refund amount; 3) Returns must be received within sixty (60) calendar days of the purchase date. If received after 60 days, a 10% (of the purchase price) penalty will be applied. If you insured the return, we will cooperate with you to file an insurance claim and adjust the refunded amount according to the receipt of any insurance adjustment.

Packages Lost or Damaged During Shipping

We generally ship USPS. For UPS, Fed-Ex and most USPS shipments, we provide tracking information for you to insure dependable service. USPS claims for lost packages require at least 30 days for the package to arrive before allowing any claim to be filed. If a USPS insured package arrives damaged, there is a minimum waiting period of 15 days before a claim can be filed, and a maximum of 60 days in which the claim must be filed.

If your order is damaged, please carefully check the contents and then inspect the shipping carton. If you receive a damaged, crushed or torn-open package and the merchandise inside is damaged or missing in any way please keep all the packaging material and contact your local USPS, UPS, FED-EX service center for assistance in filing a claim. You can file a damage claim with USPS online. Do Not return the package to us. It is your responsibility to file the claim with the carrier. We can assist in providing proof of payment and shipping/insurance information.

Warranty and Guarantee

Most of the equipment we sell consists of vintage archery equipment as much as 60 years old. Accordingly, we do not provide any warranty or guarantee that the equipment will not fail. Thus, your purchase is at some risk. We do, however, string and shoot all bows prior to sale, and do not list bows that have failed upon testing.
