NON COMPETE AGREEMENT

WINCHESTER FREDERICK COUNTY YOUTH FOOTBALL LEAGUE being the party of the first part and _____ as coach and being party of the second part, hereby agree as follows:

1. That _____ as football /cheer coach and member of our league hereby acknowledges and agrees that while being part of the coaching staff or working and/or volunteering in any such matter for the WFYFL shall NOT interact, solicit, or work for any other football/cheer program, organization, entity, club, academy or individual in the field of football or cheer aside from WFYFL without the permission of the board of directors for a period of up to one year. This includes any form of solicitation be it direct or indirect including all types of social media.
2. WFYFL strictly prohibits any coach who is either terminated of their duties or leaves upon one's own free will from making any contact or attempting to solicit any players still currently playing for and in WFYFL.
3. Any coach who is either terminated, dismissed or decides to leave upon one's own volition from WFYFL has the full obligation to turn in any equipment given to him or her while being with WFYFL teams and its related programs or party of the first part will be financially responsible for replacement costs.
