Minutes of December 18, 2017

The Huntington Township Trustees met in regular session at 7:00 PM at the Township Hall. The meeting was called to order with the pledge of Allegiance by Walter Rollin. Also present were: Jed Lamb, Tony Pluta, Dennis Finkel, Carl Strekley, Frances Rollin, John Pipcak and Sheila Lanning. Robert Holmes was absent.

Motion by Lamb with a second by Rollin to approve the minutes of the December 4, 2017 regular scheduled meeting as written. Roll call: 2 yeas. *Motion* by Lamb with a second by Rollin to approve *Resolution 2017-44* for the 2018 permanent appropriations budget of \$368,292.00. Roll call: 2 yeas. Warrants (8070-8083) and charges totaling \$13,018.56 were examined and approved for payment.

Rollin reported: Zoning Commission member Rita Rollin is interested in being reappointed to the Board. *Motion* by Lamb with a second by Rollin to re-appoint Rita Rollin to the Zoning Commission Board for a term of 5 years beginning January 2018- December 2022. Roll call: 2 yeas. *Motion* by Lamb with a second by Rollin to re-appoint Norm Dria to the Zoning Board of Appeals to a term of January 1, 2018 – December 31, 2022. Roll call: 3 yeas. Finkel talked to Zoning Commission 2017 Chairman Budi about asking StClair if he wishes to remain on the Board. No answer yet from StClair. Lamb asked if Zoning papers are in order for a new house on Stewart. Finkel stated they are in order. Furnace is fixed but the issue is due to environment. Discuss on how to correct the issue of air drawing from the basement versus from outside. Lamb asked on suggestions on how to make the furnace last. Finkel to talk to Johnson repair and come back with recommendations. Cemetery light out on the flag to be fixed. Finkel stated there is no problems with the trucks, they are ready for snow plowing and salt is dwindling. Provided paper copies of Landfill monitoring reports for October and November 2017 to forward to Lorain County Health Department. Received letter from Ohio EPA about a depression in the ponding area at the Landfill property. Sincere Condolences to the Holmes family over an unfortunate accident that happened today. Fire District to provide 3% raises across the board.

Jed reported: Rural Water Board gave out raises and there was push back on the new legal representation. Conflict arose and was unable to make the LORCO meeting.

Holmes reported: absent

Fiscal Officer reported: Last meeting of the year is set at December 30th, 10:00 AM. The first meeting of the 2018 year is Monday January 8th at 7:00 PM. Received letter from seventh grader in Utah about a trip to Denver Ohio. Will return the letter explaining Huntington is not close to Denver Ohio. Tool box cost was \$150.00 over the approved amount. *Motion* by Rollin with a second by Lamb to authorized additional \$150.00 for the tool box for the International truck. Roll call: 2 yeas.

Road Foreman reported: Shingles were dumped on Hawley Road, Game Warden found a name and address and reported to Sheriff. Received call asking about renting the Township Hall second floor. Discussion on what the fee would be and if any deposit is required.
