Unless otherwise specified, all reservations require a major credit card. Reservations are finalized upon receipt of a signed contract/agreement.

A minimum of 150.00 is required for reservation, and full payment required before Limousine departs for you're event.

Fortfiture of deposit if reservation cancelled with in 72 hours. Anything paid above the deposit will be reimbursed.

Airport pickups: Additional charges may incur for waiting time for arriving flights. There is no extra charge for the first 30 minutes of delay. After 30 minutes there is an extra \$10 charge for every 15 minutes of waiting time. For all arriving flights, meet your driver at the gate or if requested at the baggage claim area (for a fee). To avoid a no show fee please do not leave the airport before calling the office for assistance. The numbers are: (517 262-2318

A \$10 surcharge will be applied to any trip before 6am or after 10pm and certain holidays.

No possession, sale or consumption of any type of narcotics or illegal drugs is permitted. Violations will result in immediate termination of contract and services and forfeiture of all paid deposits and fees for service.

Client and renter are responsible for his/her guests, for any damage to the interior and equipment of the vehicle.

Repair and replacement of items shall have a minimum charge of at least \$100. If anyone gets sick in the car there is a \$500 clean up charge. All vehicles are quoted subject to availability at the time of booking. Rates are subject to change without notice. A deposit of \$150.00 is required at the time of booking and is nonrefundable. The balance is due at the time of the service.
