A BY-LAW TO AUTHORIZE A SPECIAL TAX CHARGE TO BE LEVIED AGAINST ALL TAXABLE PROPERTY WITHIN THE SUMMER VILLAGE OF YELLOWSTONE FOR THE 2018 TAXATION YEAR

WHEREAS the Summer Village of Yellowstone has prepared and adopted detailed estimates of the cost of the specific service or purpose and included that estimate in the budget for 2018; and

WHEREAS, the estimated amount required for the cost of the specific service or purpose is **\$108,514.00**; and

WHEREAS the Summer Village of Yellowstone deems it fair and equitable to charge equally all taxable property within the Summer Village of Yellowstone that will benefit from the specific services and purposes; and

WHEREAS the Summer Village of Yellowstone is authorized to pass a special tax bylaw under the *Municipal Government Act* RSA 2000 Chapter M-26, Part 10 Division 5; and

NOW THEREFORE, the council of the Summer Village of Yellowstone, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following special tax rates on each taxable property as shown on subdivision plans within the corporate limits of the Summer Village of Yellowstone.

2018 Special Tax Required is **\$108,514.00** for the costs of the service and purposes as follows:

- Waterworks Tax - **\$8,163.00**
 - Sewer Tax and Sewer Facility Maintenance Tax - **\$48,205**
 - Fire Protection Area Tax - **\$15,364.00**
 - Recreational Services Tax - **\$36,782.00**
2. That the amount payable per taxable property as a special tax shall be an amount of **\$649.78** levied in 2018 equally on all 167 taxable properties within the corporate limits of the Summer Village of Yellowstone.

3. That the "**Special Tax**", and said charge of **\$649.78** shall levied and included on the 2018 Tax Notice and is a debt due to the municipality known as the Summer Village of Yellowstone and is payable August 10, 2018.

4. THAT this BYLAW shall come into force and effective for 2018 taxation on the date of the third and final reading.

Read a first time on this 20th day of April, 2018.

Read a second time on this 20th day of April, 2018.

Unanimous Consent to proceed to third reading on this 20th day of April, 2018.

Read a third and final time on this 20th day of April, 2018.
