Specific matters for discussion and possible action:

A. Minimum Lot Size Ordinance-New information-Possible meeting with County Dec 7th

Chairman Korth stated that he received information from County Zoning and their land divisions. A parent parcel can only be divided up to 4 times by a CSM (Certified Survey Map). A "parent parcel" is identified as the size of the parcel back in 1997 when the County Zoning ordinance went into effect. Chairman Korth stated that we are further ahead to stay with our own ordinance. He wanted information to see what the County had. He doesn't believe we need to have them come to a meeting and discuss anything.

- B. Plan Commission—Call a meeting the week of Dec 7
- The Clerk will contact the Plan Commission Chairman and set up a meeting the week of the 7th.
 - Hintzke Brothers proposed variance

JJ Hintzke inquired of the Town Board regarding a possible variance for another lot down by his house. The Town Board referred him to the Plan Commission. The Clerk will try to get an updated CSM of the proposed area from the County ROD office and will send it to JJ and Jason Hintzke along with the agenda to the PC meeting.

- Scott Thomas rezone of 2 acres from Exclusive Ag to General Ag-Preliminary comments
- The Town Board received information regarding this possible rezone. They referred it to the Plan Commission.
 - Martin/Ethel Young Land Division Certified Survey Map

The Town Board received information regarding the division of land of 15.978 acres by Martin Young. The land is in the flood plain and not a buildable parcel. The Town Board referred this to the Plan Commission last month. It will be included in the next meeting in December.
