## **Legal Clinic Advocate Position Description**

Imani Legal Clinic is seeking UC Davis undergraduate students to join or team! The Imani Legal Clinic was established in 2015 as an entity of the Imani (Health) Clinic to service the Black/Afro Community of Oak Park. Since 2015 Imani Legal Clinic has been able to provide patients with free consultations on housing issues, health insurance, and even provided free consultation for immigration services.

Legal Clinic Advocates will have the opportunity to work directly with our attorney, coordinate their own community outreach/engagements events, and collaborate with local legal and community organizations in the Oak Park/Sacramento Area. This is a great opportunity to serve the Black community and build connections with local legal organizations/legal professionals in the Oak Park/Sacramento Area.

### **Ideal Advocate:**

**Social justice oriented and willing to learn** – personal experiences and/or relationships with the Black community are considered

- All majors are welcome! Freshmen/first-year transfers are STRONGLY encouraged to apply!!
- Have an open mind and the desire to serve the Black community
- Able to be flexible and communicate openly and honestly
- Able to take initiative on projects and follow through with commitments
- Organized able to multi-task and follow through with milt-step projects
- Able to work well in a team setting and likes to collaborate with others
- Able to commit to attending one legal clinic (or more) per month

The core mission of the Imani Clinic is to reach and service the Black community. As an advocate, we only ask that you be committed to serving and uplifting the Black community through your work and behavior both *in and out* of the legal clinic.

Imani legal clinic is recruiting for **Winter/Spring 2019** and requires a commitment for **both quarters**. **Advocates are expected to attend at least four of the eight legal clinics (dates listed below).** Attendance to bi-weekly meetings (Wednesdays 6:00-7:30pm) is **required**.

## **Program Details**

#### **Program Structure:**

Quarter 1 – The first quarter will be spent orienting Advocates to the Imani Legal Clinic:

Advocates will become familiarized with local resources and learn how to interact/network with community and legal organizations.

Advocates will meet our legal clinic attorney/team, receive ally and brief legal training, and focus on bonding/building community amongst themselves as a team.

Training dates will occur throughout the quarter and include the following:

- Ally & Legal Observer Training
- Gender/Sexual-Based Violence Awareness Training
- LGBTQIA\* Ally Training
- Mental Health First Aid
- UndocuAlly Training
- Social Justice Education Training

During our bi-weekly team meetings advocates will develop potential legal clinic workshop/information sessions for the community and begin to reach out to local community and legal organizations with the guidance of the Legal Clinic Coordinator. The team meetings will also be a time for Advocates to collaborate with each other and develop social awareness on issues faced by Black/Afro Oak Park/Sacramento Area community.

Quarter 2 – the second quarter will be dedicated to implementing everything planned during the first quarter!

Monthly legal clinic shifts and bi-weekly meetings will be dedicated to:

- Connecting and team building!
- Assisting our attorneys during each legal clinic as needed
- Collaborating with the Oak Park Community Center's Youth Explosion (YXP) Program and Imani (Health) Clinic to outreach to community members and expand the legal clinic's client base
- Engaging in community outreach, approaching community members, and recruiting new clients
- Coordinating with community/legal organizations for community-based clinic workshops and informational sessions
