The Lakewood Forest Civic Association Enriches Our Community

When you receive your billing statement from the Lakewood Forest Fund at the end of the year, you will see a line item for an optional donation to the Lakewood Forest Civic Association in the amount of \$15. Please consider including this small donation with your HOA payment. The LFCA does so much to support Lakewood Forest with fun and benevolent activities and projects, all in the name of making our neighborhood a better place to live and raise a family.

Lakewood Forest doesn't have amenities like newer subdivisions around us. We don't have a public pool, splashpad, or playground. We don't have public tennis or pickleball courts. We don't have a public clubhouse or a golf course. What we do have, however, is a volunteer group of people in the LFCA who do things to involve the whole subdivision and serve our residents' interests and needs.

The LFCA operates on a meager budget based on the annual donations made by homeowners. With income of just over \$20,000 a year, the LFCA puts on multiple events, including Breakfast with Santa, the springtime Eggstravaganza egg hunt, a 4th of July party, and National Night Out. LFCA makes donations to our local elementary and middle

schools, as well as to the Lakewood Lightning swim team and the Lakewood Forest Garden Club. LFCA sends "care" packages to our family members serving in the military, and arranges for the house numbers to be painted on the curbs in front of every house in Lakewood Forest. LFCA helps to publicize the spring and fall community garage sales. And, the LFCA writes and publishes this newsletter and updates the community website to keep all residents informed of Lakewood Forest happenings.

What's a Gardener to do in January?

In Houston, you can plant cool weather crops such as green and root crops. These include arugula, lettuces, mustard, spinach, cilantro, oregano, etc. Root crops such as radish, beets and carrots love the Houston weather at this time. Make sure they get consistent water and at least six hours of sun a day. Enjoy your harvest by April or some of these can turn bitter and tough. The best part is that most of these prefer to be germinated by seed directly in the soil – so easy and cheap! Once you taste greens from your garden, you will never be able to go back to the grocery store variety.

It was a great idea to get a live tree but what do I do with it now? Well, recycle it! They are great to be used for mulch or to help build sand dunes on the coast.

You can recycle your tree at any of the Living Earth locations during normal business hours. The closest one to Lakewood Forest is 12202 Cutten Rd. For other places to recycle your tree, check the internet.

Make sure you remove all lights, ornaments, etc. or the tree will have to go to the dump (Oh, no!)

It's too cold to go outside and garden!

Then, it is a great time to take cuttings of your outdoor plants and houseplants to propagate them. Check your specific plant to see if it will work better in water or planting directly in dirt. This is a great way to have a whole new crop of plants for your garden or to share when the weather warms up.

Remember to cut back on watering your houseplants as they, too, are semi-dormant and don't need as much water.

Let's Get into a Little Trash Talk

Your annual assessment fees cover the cost of trash and recycling. If you are a new resident, there is no sign up required...merely place your trash and recycling out on your scheduled days, which vary by zones within Lakewood Forest. You can find your zone's scheduled days from the link at <u>www.lakewoodforestfund.com/services.html</u>. Each zone has trash pickup twice a week, and recycling pickup just one of those days. Heavy trash is also picked up one day per week.

A common complaint is that the trash company isn't taking everything that is put out at the curb. Residents need to observe the guidelines given to us by Best Trash:

- Residents must provide their own trash container any size, shape or color is acceptable.
- Items must be placed curbside (no closer than two feet nor farther than five feet from the street pavement edge) by 6:30 AM.
- Daily pickup limit of four cans of properly contained household waste, each weighing less than 40 lbs.

- Yard waste items will be collected curbside. There is a limit of 4 bags/bundles per service day.
- All trash and yard waste should be placed in sturdy plastic bags weighing no more than 40 pounds each.
- All branches and tree trimmings should be no more than 3 inches in diameter and no longer than four feet in length. Bundles must be securely tied and weigh less than (40) forty pounds each.
- Bulk items/heavy trash will be picked curbside no closer than two feet nor farther than five feet from the street pavement edge by 6:30 AM. There is a limit of one item per household per pickup day.

In addition to the Best Trash rules, Lakewood Forest has a few regulations too. Trash containers, bags, and recycle bins must be kept from public view except after 6 PM the day prior to scheduled pickup. This includes lawn waste that is generated by homeowners or landscapers. Bags of grass should be kept out of sight until the proper trash day. Once trash pickup has been completed, containers and bins must be stored out of public view by 8 PM same day as pickup.
