WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$675,312.95 which includes an amount to be raised by taxation of \$552,482.00 and Total Appropriations of \$675,312.95; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on November 22,2022 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2023 and ending December 31, 2023 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on December 27,2022.

The proposed 2023 budget is \$ 125,580.47 higher than the adopted 2022 budget. The majority of the proposed increase is the result of the first payment on the capital lease for the acquisition of a new pumper apparatus approved by the voters at the February 2022 election in the amount of \$ 114,747.47. This capital lease was approved by the Local Finance Board at their June 2022 meeting and called for the payment of the 2023 lease payment from unreserved fund balance. The balance of the increase in the 2023 budget is to utilize the allowable 2 % CAP allowable under state law. The bulk of these funds were appropriate under three new categories to cover expenses for members mileage on district business, Cost related to Fire Company meeting and seminars and UNRESERVED ADMINISTRATIVE COST.

There are three new categories of expenditures in the 2023 budget which make up \$ 9,000.00 of the proposed increase in the 2023 budget appropriation which were developed to cover cost related to member personal mileage on DISTRICT BUSINESS, fire company meeting and seminar expenses and miscellaneous administrative expenses. The balance of the 2023 increase is related to debt service and is the result of a new capital lease in 2022 for the acquisition of a new pumper. This appropriation was offset by the anticipation of unreserved fund balance and therefore had no effect on the amount to be RAISED BY TAXATION

4. Complete a brief statement on the impact the proposed Annual Budget will have on the Amount to be Raised by Taxation, the use of the Restricted and Unrestricted Fund Balance(s) and how they are complying with the Property Tax Levy Cap. If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The 2023 proposed budget represents an increase in the amount to be raised by taxation of \$ 10,833.00. This is the amount allowable under the state's 2 % CAP legislation and will result in a .2 cent increase in the local property tax rate. The District utilized \$ 121,747.47 of unreserved fund balance to reduce the impact on the district taxpayers and in accordance with the proposal made to the Local Finance Board when the lease was approved by them. The proposed budget does not utilize any of the additional CAP funds available to the district.
