ORDINANCE NO. 16-2 VILLAGE OF STRASBURG, SHELBY COUNTY, ILLINOIS

AN ORDINANCE PROHIBITING SEMI PARKING ON THE CORPORATE RIGHT OF WAYS WITHIN THE VILLAGE OF STRASBURG, SHELBY COUNTY, ILLINOIS.

WHEREAS, it is in the best interest of the public safety and the safety and convenience of the residents of the Village of Strasburg, Shelby County, Illinois that an ordinance be passed and adopted fixing limits on the parking of semis upon certain thoroughfares within the corporate boundaries of the municipality for the protection of the public and the quiet enjoyment and safety of property and residents within the Village.

WHEREAS, the Village of Strasburg is authorized, pursuant to 65 ILCS 5/11-40-1, 65 ILCS 5/11-1-1, and 65 ILCS 5/1-2-1, to enact the instant Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STRASBURG, SHELBY COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. TITLE: This ordinance shall be known and may be cited as the Village of Strasburg Semi Parking Ordinance.

SECTION 2. PARKING PROHIBITED: It shall be unlawful for any person or owner to park any semi or commercial vehicle upon or along the right-of-way of any street or alley within the corporate limits of the Village of Strasburg, Shelby County, Illinois.

SECTION 3. PARKING VIOLATIONS PENALTY: Any person accused of a violation of this ordinance prohibiting parking a semi or commercial vehicle in a designated area, may settle and compromise the claim against him or her for such illegal parking by paying to the said Village Seventy Five Dollars (\$75.00) for the first offense and Seven Hundred Fifty Dollars for each successive offense within twelve months of a previous offense. Such payment may be made at the Village Hall and a receipt shall be issued for all money so received and such money shall be promptly turned over to the Village Treasurer to be credited to the Village General Fund. A separate offense shall be deemed committed on each day during or on which violation occurs or continues. Violators shall be liable for any and all attorney fees incurred by the Village of Strasburg, Illinois, relating to the enforcement of this Ordinance due to a violation on their part

SECTION 4. PRIMA FACIE PROOF: The fact that a vehicle which is illegally parked is registered in the name of a person shall be considered *prima facie* proof that such person was in control of the vehicle at the time of such violation.

<u>SECTION 5. PARKING TICKETS – STATE STATUTE:</u> The Village Board intends to utilize Illinois Compiled Statutes, Chapter 625, Section 5/6-306.5 and the procedure set forth therein. The appropriate authorities are hereby authorized to utilize the statue and the procedure set forth therein.

SECTION 6. SEVERABILITY: If any section, subsection, sentence, clause, phrase or portion of the ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed to be a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

SECTION 7. REPEAL: All ordinances or portions of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 8. COURT COSTS: The Village is entitled to recover court costs from any non-prevailing party for any and all actions brought to enforce any fine or penalty or contesting any fine or penalty brought pursuant to this Ordinance.

SECTION 9. PUBLICATION: For the reasons appearing in this ordinance, this ordinance is declared to be necessary and urgent for the immediate preservation of the public peace, health and safety, and shall therefore take effect and be in full force from and after its passage and approval as provided by law.
