President's Letter

Dear Homeowners,

I would like to address the role of Homeowners Associations and what they do and don't do. H.O.A.'s work hard to protect the value of properties in their neighborhoods. They accomplish this by working to keep the neighborhood looking attractive, and forbidding anything that detracts from the appearance of the neighborhood, such as lime green paint on a house or broken down vehicles in the yard. In our neighborhood, the H.O.A. does not control speeding, soliciting, or dogs running at large. These are issues that the city controls.

H.O.A.'s are formal legal entities created to maintain common areas. They have the authority to enforce deed restrictions. In our H.O.A., we have Covenants, Conditions & Restrictions (CC&R's) which are issued to each Homeowner. We, the H.O.A. Board, are established to ensure that everyone adheres to the CC&R's in order to maintain the quality and value of the properties involved. I would like to ask each and everyone of you to *Please Follow the Spirit of the Covenants, Conditions & Restrictions*.

If you need to make any changes to the outside of your house or yard, or have tree work that needs to be done, please contact a Board Member before proceeding in order to seek approval for the changes. We would be more than happy to discuss this with you. This will ensure the value of our investment (homes) and that our neighborhood is protected.

With your cooperation, the Conjurer's Neck Homeowners Association Board of Directors is committed to enforcing the Covenants, Conditions, & Restrictions.

Conjurer's Neck Homeowners Association's Elected Board of Directors and Board Elected Officers

Members of the Board are elected to a three year term by the homeowners present at the annual Homeowners Association meeting held in the Fall of each year. Ten percent of all lot owners must be present (in our case that means 18 lots represented) and no proxies are allowed per the by-laws of the Association. That's why it is important to make an effort to be present when you hear there is an annual meeting scheduled. Notice of the meeting is usually included on your annual maintenance dues invoice.

Officers of the Association are elected by the members of the Board and serve at the pleasure of the Board for a one year term. Officers are usually elected at the first Board meeting of each new Association year (generally at the October Board meeting).

Colonial Heights City Code 98-6 Animals

All animal owners should exercise proper care and control of their animals to prevent them from becoming a public nuisance. Molesting passerby, biting or attacking any person without provocation on one or more occasions, chasing vehicles, attacking other domestic animals, trespassing upon school grounds, or trespassing upon private property in such manner as to damage property will be deemed a nuisance. Repeated running at large after citation of the owner by any Animal Control Officer or Police Officer shall also be deemed a nuisance.
