



2022 Wayne County Association of Assessing Officers Membership Application

REGULAR MEMBERSHIP

Persons eligible for regular membership shall include officials or employees of a governmental authority in Wayne County whose duties are related to property tax assessment and administration. Regular Members, whose dues in the Association are current, shall be eligible to vote and hold office. Contractual assessors, or their employees, responsible for administering the assessment roll of a jurisdiction in Wayne County shall be eligible for regular membership.

ASSOCIATE MEMBERSHIP

Persons eligible for associate membership shall include officials or employees of a governmental authority outside of Wayne County whose duties are related to property tax assessment and administration. Contractual assessors, or their employees, responsible for administering the assessment roll of a jurisdiction outside of Wayne County, shall be eligible for associate membership. Associate Members, whose duties in the Association are current, shall be eligible to vote but shall not be eligible to hold office.

SUBSCRIBING MEMBERSHIP

Subscribing Members shall consist of those persons not eligible for Regular and/or Associate Membership, but who are interested in assessment administration and whose dues are current. Subscribing Members shall not be eligible to vote or hold office.

LIFE MEMBERSHIP

Life Members shall consist of those Regular or Associate Members who have retired from active service in the assessment profession, who petition the Executive Board in writing for life membership status within one (1) year after retirement. Life members shall not be eligible to vote or hold office. The Membership Committee shall review annually all Life Members for eligibility and report to the Board of Directors. Life membership will be reconsidered in the event that a Life Member is re-employed in assessment administration or related field.

ALL MEMBERSHIPS ARE FOR ONE (1) YEAR, RUNNING FROM JANUARY 1ST THROUGH DECEMBER 31ST.
THE BOUNDARIES OF THIS ORGANIZATION SHALL BE GENERALLY CONFINED TO WAYNE COUNTY.
