Show Dates & Hours: August 4, 5 and 6, 2020 from 10am to 5pm daily

Location: Drummer Boy Park, Route 6A, West Brewster, MA (GPS: 773 Main Street)

Set up: Monday, August 3 after 5pm and Tuesday, August 4 from 7-9am.

All booths must be set up and ready for business by 9:30am on Tuesday.

Break down: Booths may not be dismantled before 5pm on Thursday, August 6.

Application Deadline: Postmarked May 15, 2020. No late fees. (revised as of 4/4/20)

Notification: Round #1: notifications from applications received by April 1st will be sent on or after April 16.
Round #2: rolling jury until May 15.

Booth fees: 10' x 10' **\$375**; 10' x 15' **\$565**; 10' x 20' **\$750**. Corners (10 available) are an additional **\$75**. You may set up a tent inside the larger tent or use a freestanding display (Pro Panels, Flourish frame with mesh walls, etc.). Please indicate below if you plan to use a tent. All booths are located under one large white tent with side walls that are secured at the end of the day. The side walls can be lowered (in the event of rain) or raised to increase air flow and natural light.

COVID-19: if the show is cancelled due to COVID-19, artists will receive a full refund of fees including deposit.

Electricity: Electricity is included with your booth fee.

Sales tax: All exhibitors must have a valid Massachusetts sales tax certificate. Certificates must be displayed in your booth throughout the duration of the show.

Merchandise Requirements:

All work must be original and handmade in North America. It must be created by hand or with the use of appropriate tools, by the individual artist and/or with help from a limited number of assistants/apprentices. Works must high quality and demonstrate artistic originality and vision. Only work of the same medium, quality and nature as that submitted for jurying may be displayed and sold. Painting, photography, sculpture and hand-pulled prints are acceptable. Reproductions of two-dimensional artwork may not exceed 25% of available work and must be labeled as reproductions.

Work that will NOT be accepted: objects from commercially available kits, parts or patterns; any objects/works made from pre-manufactured molds; embellished commercial objects and clothing; factory-made items; assembled jewelry, or dried flower arrangements. Such items that are deemed unacceptable for exhibit may be removed from the show at the discretion of the festival committee without prior notification and/or refund.

The artist must be present for the duration of the show.

Parking: Parking is permitted near the tent for unloading/loading purposes only. All vehicles must be moved to the designated parking areas on site by 9:30 am daily and you may pull up to the tent after 5pm each day to remove stock. Parking is free for exhibitors and customers.

Security: Overnight security will be provided; however, the Society assumes no responsibility for your artwork, booth, equipment or displays at any point during the show.

Marketing: This is an artist run show and all proceeds from booth fees go toward managing and marketing the show. Full color print advertisements run in a variety of Cape Cod based magazines and newspapers prior to the event. The festival's website with the exhibitor list and a link to each artist's website, and the Facebook + Instagram pages will be used to promote the event and feature the participating artists.
