LCKC is accepting online entries for this trial through the AKC Agility Online Entry Services. Go to www.akc.org/AgilityEntry and follow the instructions there to use your "My AKC" account to enter this event online. Entries for this trial are "Unlimited".

Paper entries received within 24 hours of the opening date & time limit must:

- 1) Include postage or be metered.
- 2) Be delivered by a multi-state or multi-national postage or carrier service, including but not limited to USPS, FedEx, UPS & DHL. If above conditions are not met, the entries are not valid and must be returned to the sender.
- 3) Express mail must be designated "no signature required".

Walk-through & Warm-up

Handlers in all classes will be permitted to walk the course without a dog prior to the start of the class. At the discretion of the judge, if the size of the entry for any class might inhibit a safe and fair walk-through by handlers, height divisions may be used to divide the walk-through into groups, e.g. walk-through for the 8", 12" and 16" division handlers followed by runs for those height divisions; then walk-through and subsequent runs for the 20", 24" and 24C" divisions. A warm-up area, consisting of a regulation agility jump, will be provided. Umbrellas are not allowed on the course during the walk through.

CLASSES OFFERED & JUDGING TIMES

Classes Offered - All levels of Standard STD, JWW, FAST T2B and Premier, including the preferred classes, will be offered according to the entry form. (International Sweepstakes Classes will be offered when indicated in the premium and on the entry form). A complete set of rules for all classes is available from the American Kennel Club, 8051 Arco Corporate Drive, Suite 100, Raleigh, NC 27617-3390, or from the AKC web site. **PLEASE READ YOUR CONFIRMATIONS!! It is the exhibitor's responsibility to enter their dog in the correct class.** The Trial Secretary cannot make any changes (except for move-ups as noted) after the closing date of the trial.

Move-ups, Errors, Confirmation Protocols Move-ups after entries close must be submitted to the trial secretary in writing (mail or email) by **6 pm, Pacific time.**

Monday, Feb 17, 2020. Requests for move-ups over the phone **will not be accepted.** Day-to-day move-ups will be accepted at the trial. Move-ups must be submitted on the move-up form provided, to the trial secretary no later than 30 minutes after completion of the last class of the day.

AWARDS, RIBBONS AND PRIZE INFORMATION

Awards for qualifying scores only. All awards must be claimed at the show. Ribbons will be awarded to first through fourth place in each height division in each class.

First Place: Blue Ribbon ~ Second Place: Red Ribbon ~ Third Place: Yellow Ribbon
Fourth Place: White Ribbon ~ Qualifying Score: Dark Green Rosette

MACH & PACH ribbons and bars will be presented to dogs completing those titles
If you & your dog are close to a MACH or PACH, please let a member of the trial committee know.

High In Group - Friday and Saturday LCKC will offer a rosette to the highest scoring dog in each of the seven traditional AKC groups, plus All American and Misc., and will be awarded during the following morning's Exc Standard class briefing. Scoring is based on highest combined YPS from the qualifying STD and JWW runs.

High Junior* - Friday and Saturday A rosette will be offered to the highest scoring Junior Handler and will be awarded during the following morning's Exc Standard class briefing. Scoring is based on highest combined YPS in qualifying STD and JWW runs. *For purposes of this award, a Junior Handler is any handler 18 years of age or younger and is NOT required to be enrolled in AKC's Junior Handler program.

ELIGIBILITY AND HEIGHT DIVISIONS

Dogs Eligible to Enter

This trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club or are register-able breeds that have obtained PAL/ILP numbers from the American Kennel Club, except bitches in season, aggressive dogs, blind dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. **Mixed breed dogs** listed in the AKC Canine Partners program are eligible to enter this all-breed AKC agility trial. Mixed breed dogs entered in these events must list the breed name as "Canine Partner" (mixed breed) and not as a breed hybrid and must include their AKC Canine Partners number on the entry form and check the AKC No. Box.

Jump Height Information

All dogs without height cards will have to be measured by the judge of record, except 24"/24C" dogs. If a VMO or an AKC Representative is available, all dogs without height cards, including 24"/24C" dogs, will need to be measured. When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog has a valid jump height card or if your dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dogs on the *Dogs To Be Measured List*.

OBSTACLES AND EQUIPMENT

Obstacles ~ Obstacles shall meet the specifications for obstacles in the current edition of AKC Regulations for Agility Trials. There will be no equipment familiarization at this trial. As of 9/1/06 AKC does not allow it.

FIX AND GO ON & FEO INFORMATION

Class Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend.

Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Entering For Exhibition Only (FEO)

As of January 1, 2020, For Exhibition Only may be offered at the option of the host club. FEO will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. Competitors must enter in T2B and/or FAST. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.

- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring
 - Toys must be non-audible
 - Toys may not leave the handler's hand
 - Toys that roll freely cannot be used
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

(Note: This section only needs to be published in the Premium List if the Club is offering FEO.)

Fix and Go On (FNG)

As of January 1, 2020, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

EXHIBITOR INFORMATION

Important Information for Exhibitors

- All owners and handlers are responsible for correctly entering and participating in this trial in accordance with AKC rules. Owners are responsible for errors in entry forms, regardless of who may make such errors.
- All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. AKC does not permit pinch/prong collars, electrical or special training collars anywhere on the trial grounds.
- The safety of dogs is of primary concern. By entering the trial, exhibitors acknowledge that they are familiar with the rules and regulations of the AKC agility program, and that their dogs are familiar with and able to perform all obstacles safely.
- Confirmation of entry and a schedule of judging time will be sent to the address (email will be used when provided on the entry form) on the official AKC entry form after the closing date. If an exhibitor has not received a copy of the schedule at least seven days prior to the show, the trial secretary should be contacted. Returned checks do not constitute a valid entry. If a check is returned, the entry will be deemed invalid, and the issuer will be billed for all trial associated fees, including, but not limited to: AKC fees, judges fees and secretarial fees. **Envelopes/transactions containing entries for more than the ten (10) dog maximum shall be treated as an invalid entry.**
- Conditional, unsigned, incomplete, illegible, telephone or telegraph entries cannot be accepted. Entries not on official AKC forms or photocopies of AKC forms without the agreement form included are not acceptable.
- 100% of entry fees will be refunded if a **written request is received by the trial secretary on or before the trial closing date.** After closing, refunds will be given, **if notification is received not less than 48 hours prior to the start of the trial,** less all fees, for injured or ill handlers, injured or ill dogs. Bitches in season will receive 100% refund. **No refunds will be given if request is received after the published commencement of the trial.** Verification from a doctor or vet may be required at the club's discretion. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, acts of God, public emergency, acts of public enemy, or any other cause beyond the control of the organizing committee.
- The Linn County Kennel Club, Linn County Fairgrounds and K-9 Sports LLC assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or spectators, or to any of their dogs or property, and further assumes no responsibility for injury to any child not under the control of his or her parents or guardians.
- The Linn County Kennel Club may cancel this event in extreme weather conditions.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made. All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.
- Please clean up after your dogs while on the show grounds and at the motel site. We want to retain these facilities for future events.
- Only dogs that are eligible to be shown under the AKC rules shall be allowed within the show precincts.

Ring & Crating Information

There will be crating on the elevated spectator area around the competition. Crating space is somewhat limited, so we ask that you please conserve on space so that everyone who needs crating will be able to find a spot.
