New Business: Ms. McHale stated that the treasurer's duties are to collect- Taxes, Garbage, Utility bills. Her forensic audit results were as follows: Plante Moran audited June 2013 through November 2016. At that time, over one million dollars was unaccounted for. They did not want to investigate any further due to potentially higher auditing fees for the township. Former Treasurer Olson-DeRosso diverted funds from one account to another. Their analysis into the Township accounts consisted of: Concealed deposits, expected revenues vs. deposits, minimal cash deposits and personal cash deposits by Olson-DeRosso. The loss range was from \$959,864 to \$1,024,770. Olson-DeRosso wrote over \$200,000 in checks to herself. The insurance bonds held by both Gogebic County and Ironwood Township will hopefully re-coop most monies diverted, but due to this and many cases- the insurance agents are re-evaluating the billings- all policy holders will be charged a slightly higher rate.

Closed Session: Mark McDonald, attorney to discuss pending litigation. A motion was made by Saari supported by Graser to enter into closed session at 8 pm. Motion carried. A motion was made by Segalin supported by Brunello at 8:35 pm to go back into open session. Motion carried.
