Hall of Fame Qualifications

Meritorious Service

- 1. MUST be at least 40 years of age
- 2. MUST have participated in the sport of bowling for at least ten (10) years within the jurisdiction of the Grand Strand USBC Association.
- 3. May have participated in Grand Strand USBC Association tournament as a bowler or volunteer.
- 4. May have served as an officer or member of the Board of Directors or as a league officer
- 5. May have served as a delegate or attended a State or National Convention.
- 6. Performed outstanding service for Grand Strand USBC Association.
- 7. May have attended membership meetings.
- 8. May have performed outstanding service to the youth bowling program.
- 9. MUST have been an example of good sportsmanship, and not have been guilty of disruptive conduct in any bowling-related activity.

Bowling Achievement

- 1. MUST be at least 40 years of age.
- 2. MUST have been a member of the GSUSBCA for at least ten (10) years.
- 3. May have participated in GSUSBCA tournaments.
- 4. May have won Local, State, or National Championships in Team, Doubles, Singles or All-Events.
- 5. Achievements could include one or more of the following: 300 Game, 700 (female) Series, 800 (male) Series, Association High Average for several years, etc.
- 6. May have attended membership meetings.
- 7. May have performed services in bowling related activities.
- 8. MUST have exhibited good sportsmanship and not have been guilty of disruptive conduct in any bowling-related activity.
- 9. May have maintained a 190 average (female) or a 200 average (male) for 5 years.

Veteran Category

Recognition as a Veteran will be limited to Bowling Achievement.

- 1. Must be at least 50 years of age.
- 2. Must have been a GSUSBCA member for a ten (10) year period at least fifteen (15) years prior to the year of consideration.

- 3. The candidate shall be evaluated based on the performance standards of his or her contemporaries rather than current performance standards.
- 4. MUST have exhibited good sportsmanship and not been guilty of disruptive conduct in a bowling related activity.

Pioneer Category

<u>Pi-o-neer</u> (noun) one that originates or helps open a new line of thought or activity

- 1. Must have been instrumental in formation of Association programs, business or structure.
- 2. Must be at least 40 years of age
- 3. Must have been a sanctioned GSUSBCA bowler for at least fifteen (15) years.
- 4. May have participated in at least five (5) GSUSBCA Championship tournaments.
- 5. May have served as an officer or member of the Board of Directors or a league officer
- 6. May have served as a delegate or attended State and National conventions.
- 7. Performed outstanding service for GSUSBCA.
- 8. Performed outstanding service for promotion of bowling.
- 9. May have attended membership meetings.
- 10. May have performed services in bowling related activities
- 11. MUST have exhibited good sportsmanship and not been guilty of disruptive conduct in a bowling related activity.

Youth Support Category

- 1. MUST be at least 40 years of age.
- 3. MUST have participated in the youth bowling program for at least ten (10) years within the jurisdiction of the Grand Strand USBC Association.
- 4. May have served as an officer or member of the Youth Committee, YABA Board or as a youth league officer.
- 5. May have served as a Certified Coach.
- 4. May have served as a delegate or attended a Youth Convention.
- 5. May have performed outstanding service to the youth bowling program.
- 6. MUST have been an example of good sportsmanship, and not have been guilty of disruptive conduct in any bowling-related activity.

NOTE: GSUSBCA includes the former GSBA, GSWBA and GSYABA.
