**RECEIVER’S SUPPLEMENT TO NOTICE OF SALE  
OF 49% INTEREST IN MIDWEST MEMORIAL GROUP, LLC**

On December 21, 2015, the Receiver filed a Notice of Sale of 49% Interest in Midwest Memorial Group, LLC (“MMG”) [Doc. 138], notifying the Court and interested parties that he had executed an agreement on behalf of Detroit Memorial Partners, LLC (DMP) for the sale of DMP’s 49% interest in MMG to Park Lawn Corporation, a publicly traded company based in Toronto, Canada (“Park Lawn”). The closing of the sale was subject to the satisfaction of certain closing conditions, including obtaining approval from the Michigan Cemetery Commissioner (the “Commissioner”) for the change of control of the MMG cemeteries.

All closing conditions have now been satisfied, and the sale to Park Lawn (through its affiliate The Park Lawn Cemetery Company (USA), Inc.) closed on

March 8, 2016. The Commissioner provided full approval for the change in control of the cemeteries, and all funds due to DMP were wired to the Receivership account. As of March 8, 2016, DMP no longer has an interest in MMG.

There are certain post-closing issues that may require the use of Receivership funds to settle in the next 30 to 90 days, and the Receiver is working diligently to close those issues. The Receiver has also begun preparing a recommendation to the Court for payment of claims. Once the outstanding issues are resolved, the Receiver intends to present his recommendation for payment of claims to the Court.
