Next I'd be remiss if I didn't thank the volunteers who worked our office at the Headquarters every day from 9-5...answering phones, distributing ballots, performing an never ending list of chores for so many different people...again you had to be there to really appreciate it.

Then, came 7:30PM November 6 and we got the opportunity to view the results of our labor...thus the bittersweet taste. How sweet it is to see Moore county rise again and help solidify the election of Richard Hudson, Tom McInnis, Jamie Boles, Andrew Heath, and Michael Stone and to elect outright Ronnie Fields, Libby Carter, Ed Dennison, Scott Sheffield, and Lewin Mack Blue.

How bitter though to know that although Moore County did its part on all the judicial races, spoilers both Republican and Libertarian, handed the Jackson Supreme Court seat, the Griffin and Kitchen Appeals Court seats, and the Bibey District Court seat to Democrats...SHAME ON THEM!! Our endorsed candidate, Sammy McNeill lost a close election, again in my opinion, because of a lack of support...not from Moore GOP but from some within the Moore GOP...I suspect the Moore GOP will be very diligent in future endorsements of all candidates.

Michelle Lexo failed in her attempt to spoil the McInnis Senate race but last-minute robo-calls and photos of her with his Democrat opponent went beyond the pale...this ultimately still was a Republican vs. Democrat race. ## Election Results 2018 – Observation & Opinions:

(Editor's note; The following observations are those of your editor, based on inputs from the usual sources: Television ads, election commentators, friends and neighbors, many online news blogs, and, of course, my wife)

**My comments will follow the order of the candidates as reported earlier in this newsletter. As a reminder, that order is based on the Moore County Sample Ballot handed out at our luncheon meetings and as included in past newsletters. That ballot was produced by the Moore County GOP and included their recommended candidates for your vote.**

**I will start with the election turnout. It was not just good, rather I would say much better than expected! At the local, state and national level, both sides removed all the stops and every possible effort (and then some) was made to assure that voters were registered and showed up to vote. Without getting bogged down with numbers, it has been stated by many that at worst the turnout will be the same and at best greater than all recent mid-term elections, as predicted. It was not as large as past Presidential elections, but a very good turnout, perhaps greater than expected. This large turnout is in the face of there not being a major statewide election in this midterm.**

Why did this large turnout occur? As already stated, both parties did a good job of getting out the vote. But, beyond that, I believe the voters were motivated to come out for a number of reasons (also read issues):

- Hoping for a “Blue Wave”
- Fear of a “Blue Wave”
- Hoping to upset the current power structure
- Fear of upsetting the current power structure
- Because voters “love” President Trump
- Because voters “hate” President Trump
- Hoping to continue the “Trump” agenda
- Hoping to stop the “Trump agenda”
- Wanting to continue or stop the illegal immigration policies
- Wanting to continue or reverse the income tax policies
- Wanting to support the local/state candidates of your choice
- Wanting to support or reject the local/state referendums

Of course, this is not a total complete list of reasons, mostly those that have been discussed by the media and political pundits. I am sure as you read this, you can think of many more reasons for the outstanding turnout.

A couple of other observations about the NC turnout: There was, at the local and state level as expected, a fantastic turnout for early voting. We had seen projections that as many as 60% of the vote would be through early voting. As it turns out the total vote was much greater than expected thereby making the early votes and election day votes somewhat even out. Our past results indicate that early voters tend to be more Democrat than Republican. That leaves our GOP supporters being required to vote on election day, which they seemed to do, at least on a local Moore County level.

Now let’s look as some of the individual races, both local and statewide as it relates to races where Moore County Residents could vote. Again, I am commenting on those races that were on the ballots we all say whether we voted early or on election day.

First, let’s look at the statewide races. There were NO races with candidates for a statewide office. This is often called a “blue moon” mid-term election and normally results in a very low turnout. However, there were six proposed constitutional amendments on the ballot. Looking at the results for the amendments as posted earlier in this newsletter, we see that the first four on the ballot passed with a strong margin. These amendments were not generally opposed (based on ads and TV

commentators) and addressed non-controversial issue, except voter ID. As a result of these passing, we will be able to hunt and fish, get information if we are a crime victim, be assured that we will never pay more than 7% state income tax and best of all, finally have a voter ID requirement!

The final two amendments failed as strongly as the others passed. I believe that were two obvious reasons for the defeat:

- There was an effective and comprehensive ad campaign against these two amendments that convinced the electorate that they were not in the best interest of North Carolina. And, I believe, it took away power of the Governor, a blatant partisan effort to impose a negative impact on a sitting Democrat Governor.
- The opposition, which appeared to be bi-partisan effort, had a comprehensive ad campaign which explained why we should NOT vote for these amendments while those who were for them did NOT have a good or any explanation for why we should vote for the amendment.

Now, to the election results for races for state and local offices. First, let’s look at the offices that include beyond Moore County. The race for US Congress in District 8 includes Moore County as well as additional territory to the southeast and to the west. Incumbent Congressman Richard Hudson was re-elected in a fairly close race with Helen Mills. One reason may be that he ran a positive campaign telling about his accomplishments and what he stood for, not jumping on the negative bandwagon.

In the NC State Senate and the two NC House races that included Moore County, the Republican candidates Boles and McNeill won easily. Again, their campaigns were by in large run on a positive basis. The Moore County offices including Sheriff were a clean sweep for Republican candidates. We as a Republican Men’s Club can take partial credit as we took a supportive position for these races with all winning candidates being club members.

The Judicial races were another matter, and not a good result! In the statewide NC Judicial races, one for NC Supreme Court and the three NC Court of Appeals seats where there were two or more candidates, the GOP was 0 for 3! Yes, we lost all 3 of them. Some credit goes to the Democrats for spending the money and effort to campaign for these races. We saw TV ads for Anita Earls for NC Supreme Court all day, every day on TV. At the same time there was a total lack of TV ads for the sitting Republican US Supreme Court Judge, Barbara

Jackson. Likewise, for the Court of Appeals Judicial races, the TV ads and other promotions were either lost in the advertising maze or non-existent. I have to ask, "Where was our GOP promotional support for these judicial races?" As a final comment on this matter, I must note that the Dems pulled a fast one or the GOP folks fell asleep at the wheel. How, you ask? Well, there was a second Republican candidate in 3 of those 4 races, meaning the Republican vote was split. If you add the votes together for the two Republican candidates, the Republicans win all three of those races!! Somehow, we must learn a lesson about these races and not let this happen again. Further, I predict we could pay a high price and see many of the conservative gains and future conservative initiatives thwarted by judicial actions and activism. Time will tell!

Other nonpartisan County offices, in most cases, were won by the Republican backed candidates. One exception was a Moore County Board of Education seat. This demonstrates that our efforts to back candidates and get out the vote are effective in most cases.

#### November Meeting Program News by Pat Haggerty – VP Programs:

##### N.C. TREASURER DALE FOLWELL IS KEYNOTE SPEAKER ON 11/19

Dale Folwell used to be a blue-collar worker and decided to point his life in a new direction. He earned a B.A. and M.A. in accounting and then passed his CPA exam. He served in NC Legislature and then was elected NC State Treasurer in 2016.



As the keeper of the public purse, Folwell is responsible for \$100 billion state pension fund that

provides retirements benefits to 900,000 teachers, law enforcement officers and other public employees. This retirement fund is rated as one of the five best managed pension funds in the country.

NC enjoys the coveted AAA bond rating and is only one of 13 states to have this highest rating. Folwell also oversees the state health plan which oversees medical and drug benefits to more than 720 current and retired public employees.

In addition to Folwell, we will have a short presentation by Glenda Clendenin, Director of the Moore County Board of Elections who will present some interesting information about the November Election numbers in Moore County. She will also be available for Q&As from attendees.

Our meeting will be at CCNC with registration beginning at 11:30am with the meeting called to order at noon. After opening remarks and introductions, lunch will be served followed by our speakers. Reservations are required.

#### Steve Woodward – Secretary:

As you likely know, the club secretary is the keeper of the club's records. One of those that is of key importance is the official club membership database. Included in this database is information about every member such as name, contact information, date of membership, membership status and much more. Three of those data fields are in need of updates. They are:

- Email address (and other contact information)
- Preferred method of notice and making monthly lunch reservations
- Name of recruiting club member or close club member who is a friend or relative

We are asking each member to read the following explanation about why we collect this information and ask you to send an update so we can get our records current.

**Email address (and other contact information):** This information is obviously needed to allow us to stay in touch with our members. We have found over the years that people move, change their telephone number and in particular, change email address. So, we are asking that you please let us know the following:

1. If you have moved or otherwise changed your mailing address in the last year, let us know.



2. If you have changed your telephone number, your cell number or added a cell number in the last year, let us know. We would like to have the number in our records that you prefer to receive calls or texts about club business.
3. If you have changed or added an email address in the last year, let us know.

**Preferred method for notice and lunch reservations:**

We have stated in previous newsletters that we now get luncheon reservation information from various sources. So, we have a column in our membership database that states the preference of our members based on how they normally make their monthly luncheon reservation. Those methods of luncheon reservation and confirmation include:

- Telephone call from a calling captain
- Email from a calling captain or other member
- Text reservations
- Website reservations

We have populated less than half of the preferences in our database. Please let us know how you would like to be notified of meetings and how you would prefer to make your monthly luncheon reservations based on the methods noted above.

**Recruiting club member or close club member friend or relative:**

This is a fellow club member that brought you to the club or one you have as a personal friend that is also a member of the club. We use this information if we lose track of a member; they are the person we contact if we cannot otherwise reach a member. Please let us know who's name you would like to have as your club recruiter or friend.

Well, the good news is that the fall election is over, well almost over. As I write this, there are still unsettled races in Florida and Arizona! Duh, so what is new! More on this later. Even with these races still open, at least we will not be subjected to more local (state of NC)

political ads calling most candidates low life, criminal, cheatin' and lying sub-human dogs! Well, maybe not that bad, but close.

Having gotten that off my chest, allow me to address an issue that requires attention as we move toward 2019. That issue is the notification of members about our monthly meetings and the simultaneous request for luncheon reservations.

As we have stated in the last few issues of this newsletter, our membership has, over time, begun to migrate to social media as a means to get information about monthly meetings and to make reservations. Here are the ways members are now using to get luncheon notifications and make reservations:



- Club website, [www.mcrmc.club](http://www.mcrmc.club)
- Email notifications with reservation response
- Text notifications with reservation response
- Paper copy US mail notification by either the newsletter, a separate mailing or both
- Telephone notifications with reservation response (The primary method in the past)

In addition to this migration to social media notifications and response, the Calling Colonel/Captain administration changed to a new administrator, Bob Coates.

With these changes we believe it is time to move forward with updates to the notification/reservation system to recognize our members preferences. Accordingly, we are proposing the following steps to implement this update:

- Update our records to reflect individual member's notification and reservation preference

- Rename the head of lunch administration to "Lunch Administrator" and those who do notifications to "Lunch Captains."
- Update the list of member's preference for receiving lunch notifications and to make lunch reservations to include the method used; i.e. email, text and/or phone
- Get notification preference as new members join the club
- Remind members monthly about luncheon information and reservation requirements using their preferred contact method

Our calling captain system has served our club well over the years and we want to be sure and continue to use telephone contact for those who want it. However, we also need to recognize other preferred methods of communication to recognize changing habits of younger members and future members. On another subject, in a previous article found starting on page 4, I expressed some observations and opinions about the recent election. Mostly, those were related to the North Carolina results, not much about the general flavor of the national elections. In general, I would describe the national flavor as "bitter!"

Why, you ask? I would suggest the bitter flavor would be more about the reaction not results (how about that for alliteration). First the state of North Carolina. We lost the "super majority" in the NC general assembly. This result was, in part, brought about as a result of TOTAL negativity on the part of the Democrat campaign, a very bitter approach. Unfortunately, the NC GOP did not seem to have a "positive response" strategy, rather a "no response" strategy which worked well in the densely populated metropolitan areas, which already tended to lean to a Dem majority. At the national level, is there really a need for me to point out why this was a “bitter” election. Just watch the news, any source, and you will see the rancor that continues about the election results; see Arizona and Florida. Not necessarily the results, but the process. I

suggest that if we, as a nation, cannot get the voting process right, our country is LOST. Time will tell, but I am not very optimistic at this point.

Inside Politics: Races Won with Under Half the Vote

Most voters in the 9th Congressional District voted against Republican Mark Harris in this year's election.

And yet he won.

Similarly, more than half of the voters in the whole state this year voted against Democrat Anita Earls for the North Carolina Supreme Court.

And yet Earls will pick up a gavel in January. She defeated Republican incumbent Barbara Jackson.

Earls had 49.45 percent of the vote in her election. Harris had 49.43 percent in his. More than half the voters in their elections wanted someone other than them to win.

Earls' and Harris' victories show what can happen when election laws allow more than two candidates to be in a general election and allow candidates to win with plurality instead of 50 percent plus one.

Now that the state has five recognized political parties plus more than 2 million voters who don't belong to any party — more than 2 million potential candidates — winners who take a minority of the balloting stand to become more common.

Elsewhere on this year's ballot, two Court of Appeals candidates won with less than half the vote, as did eight local judge candidates.

In unofficial returns, two state Senate candidates and three state House candidates were in first place as of Friday even though most of the voters in their elections wanted someone else. (Some of these results could change as absentee and provisional ballots are added to the returns.)

There were similar plurality results in other local races Tuesday.

North Carolinians soon may ask: If a person knows he can win an election with less than half the votes, how much will he listen to the majority of people in the district? If a candidate must get at least 50 percent or more to win, he has to pay attention to a larger group of people with more diverse interests.

Consider that on Tuesday, a candidate for District Court judge in western North Carolina won a five-way race with 27.37 percent of the vote. Nearly 73 percent of the voters in Alexander and Iredell counties voted against her.

One caveat about the 2018 races: The judicial elections were unusual in that the legislature canceled judicial primaries that would have narrowed the field. There were multiple Democrats and multiple Republicans in some races.

But North Carolina's other elections conducted partisan primaries as usual this year and some had under-50-percent winners on Tuesday.

North Carolina's partisan primary process won't keep the Libertarian Party, the Green Party or the Constitution Party off the general election ballots. Third party candidates can prove to be spoilers.

In 2016, Democrat Roy Cooper became governor with 49.02 percent of the votes, and in 2014 Republican Thom Tillis was elected to the U.S. Senate with 48.82 percent. If the Libertarians hadn't fielded candidates in those elections, would Republican Pat McCrory still be governor? Would Democrat Kay Hagan still be a senator?




On the one hand the GOP with a campaign based on economic results, common sense, on family, on work, on the respect of law, on legal immigration, and on security.
