I don't think any of us ever imagined we'd be in the midst of a Global Pandemic and the many challenges that it would bring. My heart and prayers goes out to my AMVETS Auxiliary families that had to deal with the coronavirus. As we begin a new year of uncertainties we as an organization still have responsibilities. Many auxiliaries are still not meeting due to COVID-19. So, here are some suggestions to the auxiliaries listed below that bylaws are due before the 2021 Department Convention.

1. If you are not meeting, please wait until the Department, February SEC Meeting for further instruction.
2. If your auxiliary is meeting please remember that the bylaws committee must meet with the Parliamentarian chairing the meeting. The Parliamentarian shall present the recommendations from the committee to the members at one meeting and read again at the next meeting with a vote to accept the recommendation. If approved follow the instruction below.

All local Bylaws shall be approved by the Department President and Parliamentarian. Bylaws shall be studied for revision every three year. Don't forget to include the bylaws cover sheet when mailing bylaws and complete the information at the top of form which includes the person sending the bylaws, address, telephone number and e-mail address. The bylaws cover sheet can always be printed from our website listed under forms and includes instructions of sending: (1) one copy of your minutes and three (3) copies of bylaws signed by the President and Parliamentarian. Also, minutes should always include the actual motion and approval of any bylaws changes.
